Service and Resource Planning Worksheet

September 2024

To a significant degree, the assessments, service, and resource plans provided by intake clinicians define participants' experiences in the Supervised Release Program. "The Service and Resource Planning Worksheet" structures responsivity measures by supporting intake clinicians' completion of holistic assessments of participants' needs and goals and translating those findings into responsive service and resource plans. The tool also serves documentation and communication about participants' presentations and intervention plans.

Supervised Release Expansion

December 2023

In 2023, the mayor's office for the city of New York significantly increased funding for the Supervised Release Program (SRP) city-wide. The expanded funding included an additional \$14 million to support program operations in Brooklyn and Staten Island specifically. This infusion of funding created a critical opportunity for strengthening program infrastructure, including a re-imagining of staff roles and increasing quality assurance systems to ensure the program fulfilled its mandate and employed best practices aligned with organizational values. Towards those goals, a significant number of staff roles were reconfigured, new positions were created, and the number of staff were increased at both project sites. These structural changes provided increased quality assurance and oversight of day-to-day operations, adequate staffing, and reduced caseloads, increasing the program's ability to provide robust specialized support to participants.
