**A SENATE RESOLUTION TO BE ENTITLED AN ACT TO RECONFIRM MARIA ECHEVERRY MONTANO TO THE POSITION OF CHAIR OF THE BOARD OF ELECTIONS**

**WHEREAS**, Student Body Statutes §6-2.8. **Appointment of the Chair of the Board.** states,

“The Chair of the Board of Elections shall be considered a Student Government Official. The outgoing Student Body President shall appoint the Chair no later than one week prior to the first Student Senate meeting of a new session, subject to the simple majority confirmation of the Senate. Such an appointment shall not be confirmed at the meeting at which the appointment is announced. In addition to any specific requirements, the Chair of the Board shall meet all requirements for service as a Board Member, as listed in SBS §6-2.3. The term of the Chair shall begin on the effective date of confirmation and last until the date of Spring Commencement. The Chair shall be confirmed a second time prior to discharge of duties regarding the Spring General Election. Such confirmation resolution shall automatically be introduced the second to last Senate meeting of the fall semester.

Any removal or dismissal of the Chair by the Student Body President shall be overturned by a two-thirds (2/3) majority vote by the Student Senate, allowing that a proper motion is introduced and seconded at any meeting of the Student Senate.”

**WHEREAS**, Maria Echeverry Montano is the current duly appointed Chair of the Board of Elections;

**NOW, THEREFORE BE IT RESOLVED**, that the North Carolina State University Student Senate hereby reconfirms Maria Echeverry Montano as the Chair of the Board of Elections for the 101<sup>st</sup> Session of Student Government; and be it further

**RESOLVED**, this resolution shall be effective upon its adoption.
