#### Active Shooter Training: The Rapid Response and Treatment Model

Active Shooter Response: The Rapid Treatment Model, is available free of charge by download. This 30-minute video program and accompanying 29-slide PowerPoint presentation compose an introduction to the third generation of active shooter response. Unlike previous approaches, the Rapid Treatment Model integrates fire/EMS with the law enforcement response, and the focus is on getting aid to the wounded within the golden hour, even while law enforcement is still clearing the structure. It allows EMS personnel to work is a safe, secured zone simultaneously with law enforcement clearing, and it does not demand complicated cross-training between agencies.
