#### **Abstract**

An abstract is presented separate from the article, enables the reader to identify the basic content of a document quickly and accurately, informative and completely self-explanatory, provide a clear statement of the problem, the proposed approach or solution, and point out major findings and conclusions. **Abstract (font size 9pt) should be 80 to 200 words in length.** References should be avoided, but if essential, then cite the author(s) and year(s). Standard nomenclature should be used, and non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself. No literature should be cited. **The keyword (font size 9pt, alphabetic order) list provides the opportunity to add 2 to 5 keywords**, used by the indexing and abstracting services, in addition to those already present in the title.

## **INTRODUCTION**

Above of the introduction title is 2 line spacing 11pt and below is 1 line spacing 11pt. The introduction is written in all capital letters (**UPPERCASE**). Introduction includes background, current state, problem formulation, and research objectives. Any words that are foreign terms must be italicized. All are written in **Segoe UI** font with 1 line spacing. The first paragraph for each section is not indented. Please follow this template, you should not change, fill in your writing directly in this template. Changing this template may cause formatting mismatch. The following is an example of a citation reference (Tawandorloh, Islahuddin, & Nugraheny, 2021). The column is **0.8 cm**. The main text format consists of a flat left-right columns on A4 paper. The margin text from the left, right, top, and bottom are 3 cm. The manuscript is written in Microsoft Word, single space, **Segoe UI (11pt)**, as many as 7-15 pages, which can be downloaded at the website:

The second and subsequent paragraphs are made by **indenting the first line as far as 0.8 cm**. We request authors to follow the guidelines outlined in this example for consistency. Here is an example of a citation reference (Mentari, Yuni, & Vioeza, 2021). Papers in a form that technically does not match the guidelines, the editor will return it to be corrected or retyped. Once returned, the manuscript must be modified appropriately and according to the guidelines (Nugraheny & Kusuma, 2018; Theresia, Syafi'i, & Vioeza, 2020).

A concise and factual abstract is required. The abstract should state briefly the purpose of the research, the principal results and major conclusions. An abstract is often presented separately from the article, so it must be able to stand alone. For this reason, References should be avoided, but if essential, then cite the author(s) and year(s). Also, non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself. Immediately after the abstract, provide a maximum of 5 keywords, using American spelling and avoiding general and plural terms and multiple concepts (avoid, for example, 'and', 'of'). Be sparing with abbreviations: only abbreviations firmly established in the field may be eligible. These keywords will be used for indexing purposes.

## RESEARCH METHOD

Before writing the title of the method, leave a distance of 2 line space of 11pt, and below (of the title) is 1 line spacing 11pt. Explaining research chronological, including research design, research procedure (in the form of algorithms, Pseudocode or other), how to test and data acquisition (Hair Jr et al., 2016). The description of the course of research should be supported references, so the explanation can be accepted scientifically.

**RESULT AND DISCUSSION**

Before writing the title of the results and discussion, leave 1 line space 22pt. The results of the study are descriptions based on the types of data collected according to research methods. The results and discussion must match. In the structure of the article, the results and discussions can be created separately, like "Research Results" and "Discussion", so the author is allowed to adjust them according to their needs in presenting the content of the article. The Result should include the rationale or design of the experiments as well as the results of the experiments. Results can be presented in figures, tables, and text. The Discussion should be an interpretation of the results rather than a repetition of the Results.

**Sub section 1 (11pt)**

Above from the title of the sub results and discussion 1 leave 1 line spacing 11pt. The results should include the rationale or design of the experiment as well as the results of the experiment. Results can be presented in Figures, Tables, and text. Discuss the results yourself. Add a definite discussion related to Figure or Table.

In the discussion there must be citations/references from other research results. Compare how your research results with relevant research. In the discussion there must be citations/references from other research results. Compare how your research results with relevant research.

**Sub section 2 (11pt)**

Above from the title of the sub results and discussion 2 leave 1 line spacing 11pt. The discussion should be an interpretation of the results rather than a repetition of the results.

Please add a definite, valid and reliable discussion. In addition, also include references that match your explanation. Don't use broad explanations, use appropriate sentences (Vioreza, Supriatna, Hakam, et al., 2022).

**Sub section 3 (11pt)**

Above of table title leave 1 line spacing 11pt. Each table must be numbered with Arabic numerals (e.g., Table 1, Table 2) in order and include a caption. Tables should always be captioned above them. Text using single line spacing should be centered and should not create the same table but separate on two different pages.

The font size used in the table is 11pt. Table Contents must not use bold font style. Table posts are not allowed to be made vertically. The table does not display vertical lines. Make it 11pt line spacing at the top and bottom of the table. Examples can be seen in Table 1. Contents must not use bold font style. Contents must not use bold font style.

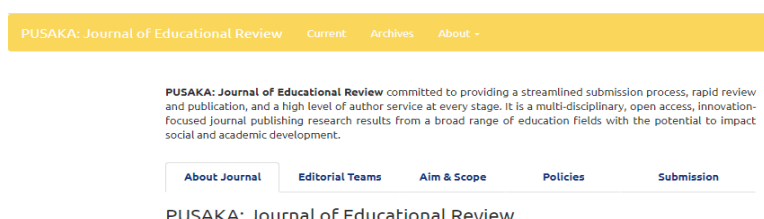


Figure 1. The Caption about Figure

The numbers that match the equation must appear sequentially in each section or in the contribution, with the numbers enclosed in parentheses and set at the right margin, starting with the number 1 and continuing.

A paper was published by two authors, the reference is **Vioreza and Utami (2021)**. A paper was published by three Authors, the **first reference** in the text is **Vioreza, Utami, and Nugraheny (2022)**, but in subsequent citations for three to five Authors, only use the first author's last name followed by "**et al.**" in the signal phrase, like **Vioreza et al. (2022)**. The author(s) must check the accuracy of all cite listed reference, as the PUSAKA: Journal of Educational Review will not be responsible for incorrect in-text reference citations.
