Directions: In order to create an Outline for your Persuasive Essay, first complete the table from Step 1 with the information you already developed for your persuasive essay. Then, if you would like to move towards a more detailed outline, you *can* adopt one of the options from Step 2, but that's optional. At the very least, your Step 1 outline should include

- 1. Debate + Claim
- 2. Supporting Points and Evidence: Clearly list each point as a single sentence. Next to each point, explain how you intend to support it: with research, hypothetical examples, personal experience, or something else.
- 3. At least one counterclaim.

Some of you may also wish to briefly define key terms at the beginning of the essay body, but that's also optional.

Step 1 (required): Identify Claim, Supporting Ideas, and Counterarguments

Introduction	Debate : What's the best way to prepare students for the workplace?

Step 2 (optional): Adopt a more specific outline

If you would like to have a more specific plan for your persuasive essay, you can adopt one of the Outline Options below, then plug in your information. Each of these outlines can be modified further, as needed. The main difference between Step 1 and Step 2 is that the latter is more intentional about the placement of counterclaims (what "they say") in your essay. Counterclaims can appear at the beginning of the body, the end, or even as a way to open your introduction. They can also appear after every supporting point in your essay, as a way to add discussion to your own ideas.
