  - a. Work with e-board to get the word out, draft emails for each department to send out, social media schedule as a count down to elections, information sessions, in-person presence (table outside Zankel or Everett)
- University Senator Lee: How can we use Slack to build community while also being professional?
  - a. Setting standards from Day 1, setting community standards and adhering to those through monitoring the channel, collaborate with different senators and e-board to determine the best avenue of communicating with one another

## 2. Letter of Support: Dr. Gordon Brian Ahn

- a. First Reading (10 minutes)
- b. Q and A (10 minutes)
  - i. Senator Heidelberg: See the change in “Gordon-Donor Name Tower.” Any documentation or proof that states the email from President Bailey is false that he declined the offer
    - Please see the letter in the section titled “Dr. Gordon’s Proposal”
  - ii. Senator Lamanno: the first “whereas” person that created it is not a cosponsor
    - Senator Niazi: I thought Jonathan Coulson was the person that said that
    - Senator Lamanno: The first one is from Tina and Kristina
    - Senator Ahn: I have evidence that these people support it
  - iii. Senator Heidelberg, point of clarification: Are the co-signers current TC students?
    - They were former TC students
  - iv. Parliamentarian O’Brien: Why Dr. Gordon and not a woman of color for example?
    - Dr. Gordon asked us to continue to push for this
  - v. Motion to extend questions 5 minutes, seconded, passed
  - vi. Communications Officer Regis: Why specifically Dr. Gordon?
    - Dr. Gordon told us to keep pushing for it

- Communications Officer Regis: It doesn't seem like he wants to be on it in the email that you offered, so I'm a little confused.
- He specifically told Barbara Wallace
- vii. Senator Jones: Since the other cosponsors aren't Senators, are they allowed to be on the legislation?
  - Don't have guidance that they can't be on it
- viii. Senator Pant: Explicitly stating that he is not going to protest as long as the building is named after a person of color
- ix. Motion to extend 5 minutes, seconded, passed
- x. Senator Ahn in response to Senator Pant: It is what Dr. Gordon wants and he has told us numerous times that this is what he wants
- xi. Senator Anigbogu: At what point do we go back to the drawing board to consider someone else, or maybe someone with Dr. Gordon to be honored in this way?
  - Barbara Wallace already in conversation about this
- xii. Motion to extend 5 minutes, seconded, passed
  - Parliamentarian O'Brien: I sent you recommendations regarding the last letter, but I do not see them implemented in this new letter
  - I have timestamps that specifically address your concerns. I was speaking with Krystal and she wasn't sure what she could share. This is what we can give, if you want I just want to vote

      1. They have to resign to the president and the position would come for rolling admission in the fall.
    - ii. Senator Garcia Tulloch: I think it sounds really good
      1. Thank you! We tried our best to consider everyone's suggestions
  - iii. Parliamentarian O'Brien: Will exclude 2nd year masters students from joining e-board, 2 semester term excludes the summer option of having summer is important in case you want to make changes to the constitution, rolling admission issue-orientation in the spring, would you have to keep orienting senators in the spring?
    1. Can we say 3 summers? The Constitution was an e-board thing. Normally we don't have any value in the summer. Technically your term ends in the summer. With this you would continue in the summer and the fall
    2. Rolling admissions-would only help people in these spots, would help with attrition
