Based on the analysis of your information, we aim to optimize and improve the product. The data will not be transferred or used for other purposes and will only be processed in accordance with this statement.

Please be aware that if there are errors in our app, we may transmit data and information on your phone to the Appmetrica service through third-party products and other services that may collect data.

As stated in the AppMetrica service privacy policy, we may collect data about your device, including IP address, name, operating system version, application configuration, time and date of use, and other statistical data when you use our service.

## Automated Information Sharing

For Android, collection of advertising identifiers is not required. The user can manage this identifier in Android settings by choosing to change or delete it.

Restricting advertising activities may stop sending advertising identifiers and other data due to the functionality of the Google Mobile Advertising SDK.

### **Working with information**

Google Mobile Advertising SDK may automatically collect and send various types of data for purposes of advertising campaigns, anti-fraud, and analytics data collection.

### **Personal Data Security**

The Villagers & Pillagers Minecraft application protects your data during transmission, such as the HTTPS protocol.

Villagers & Pillagers Minecraft expects your permission to process your data, except for certain settings that can be configured in the application.

### **Organization**

We capture a user's basic geolocation, such as country or region, for statistical analysis without defining detailed coordinates.

### **File Evidence**

We analyze stored Minecraft data on your device for a limited time. This feature is necessary for the normal operation of the application, so it cannot be disabled. For example, we check if there is Minecraft on your device.

### **Activity monitoring**

To improve the functionality of our product, we monitor how you use the Minecraft app and collect data about other apps associated with your device.

### **Security Precautions**

We value your data protection and privacy. By analyzing error logs and reports, we are constantly improving our product to quickly detect and resolve issues.

### **Partnerships**

We partner with various organizations and professionals to improve the quality, distribution and implementation of new features of our application, and to study user behavior.

We strive to inform users about how our partners can access their personal data. However, these partners must comply with our privacy policy and not use the data to circumvent their agreement with us.

### **Data protection for younger users**

Our product is intended for an audience over the age of thirteen. Use of the app by children under this age requires permission from a parent or guardian. We do not collect information from people under the age of thirteen; if we do, we will delete it.
