Authors are encouraged to use recent references, preferably published within the last five years, and follow APA 7th edition citation style, for example: (Boone et al., 2023; Shashi, 2025).

Furthermore, the introduction should clearly state the novelty, research problem, objectives, and argument or hypothesis of the study. The research objectives must align with the identified gap and demonstrate the contribution of the study to theory, practice, or future research. For qualitative studies, authors may present research questions or propositions instead of formal hypotheses.

RESEARCH METHODS

Data interpretation should be reserved for the Discussion section; the Results section focuses on clear, accurate reporting.

Findings can be supplemented with tables, figures, graphs, charts, diagrams, or schemes to improve clarity and comprehension. All tables and figures must be numbered consecutively and include descriptive titles. Tables should have the title placed at the top (recommended format: Book Antiqua, Bold, 10 pt), and figures should have the title placed below the image (Book Antiqua, 12 pt). Each table or figure should be self-explanatory, allowing readers to understand the data without referring extensively to the text.

The Discussion should also address the practical and theoretical implications of the results, illustrating their relevance for policy, practice, or further research. Limitations of the study must be explained, including how they may affect the interpretation, reliability, or generalization of the findings. Finally, authors are encouraged to suggest directions for future research, including extending the current study, exploring related topics, or addressing identified limitations. Overall, the Discussion provides a deeper understanding of the results and a broader perspective on the research topic.

CONCLUSION

The conclusion summarizes the study's main findings and provides recommendations or suggestions for further research. The author should emphasize the study's contribution to the relevant field and explain its implications. If there are practical recommendations, these should be clearly stated, as well as suggestions for future research, either to extend the study or to address existing limitations.
