Privacy Policy

At **BabyStop App** ("we," "our," or "us"), we value your privacy and are committed to protecting the personal information you share with us. This Privacy Policy explains how we collect, use, disclose, and protect your information when you use our app, which helps parents find clean, family-friendly baby spots nearby.

By accessing or using our app, you agree to this Privacy Policy. If you do not agree to this policy, please do not use our app.

1. Information We Collect

We collect different types of information to provide and improve our services to you. This includes:

A. Personal Information

When you use BabyStop app, we may ask you to provide personally identifiable information, such as:

- Name: To personalize your experience.
- **Email Address**: For registration, communication, or account-related purposes.
 - **Phone Number** (optional): To contact you directly, if needed.

B. Location Data

To provide location-specific results and recommendations (like nearby baby spots), we may collect:

- **Precise Location**: When you enable location services on your device, we collect GPS data to help you find nearby baby-friendly spots.
- **Approximate Location**: If you don't enable precise location services, we may infer your location based on your IP address.

You can disable location services at any time through your device's settings, but doing so may limit some features of the app.

C. Usage Data

We collect non-personally identifiable data to improve the performance of the app and enhance user experience, including:

- **Device Information**: Information about the device you use to access the app (e.g., device type, operating system version).
- **App Usage Data**: How you interact with the app, including pages you visit, actions taken, and crash reports. This helps us improve the app's functionality and troubleshoot errors.
 - **IP Address**: Used for analytics and to detect malicious activity.

D. User-Generated Content

When you submit reviews, ratings, or comments about baby spots, this content may be visible to other users. We may also collect photos or other media you upload to enhance your experience in the app.

2. How We Use Your Information

We use the information we collect for various purposes, including:

• **Providing Services**: To show you nearby baby-friendly spots, recommend locations, and enable you to save favorites or leave reviews.

- **Personalization**: To offer a customized experience based on your location, preferences, and interactions with the app.
- **Communication**: To send you account-related notifications, updates, promotional materials (if you've opted in), and responses to your inquiries.
- **Improving the App**: To analyze usage trends, troubleshoot issues, and enhance the app's features and functionality.
- **Legal Compliance and Security**: To comply with legal obligations, enforce our Terms of Service, and protect the security of the app and users.

3. Sharing Your Information

We do not sell, trade, or rent your personal information to third parties. However, we may share your information under the following circumstances:

A. Service Providers

We may share information with trusted third-party companies that help us provide and maintain the app, such as:

- Hosting services
- Analytics services (e.g., Google Analytics)
- Payment processors (if applicable) These service providers are required to use your data only for the purposes of performing services on our behalf and are bound by confidentiality agreements.

B. Legal Obligations

We may disclose your information if required by law or to comply with legal processes, such as:

- Responding to subpoenas, court orders, or government inquiries.
- Protecting the rights, property, and safety of our users or the public.

C. Business Transfers

In the event of a merger, acquisition, or sale of our business assets, your personal information may be transferred as part of the transaction.

4. Data Security

We take appropriate technical and organizational measures to protect the personal information you provide to us. This includes:

- Encrypting sensitive data.
- Implementing firewalls and access controls.
- Regularly monitoring our systems for vulnerabilities.

However, no method of data transmission over the internet or electronic storage is completely secure, and we cannot guarantee the absolute security of your information.

5. Cookies and Tracking Technologies

Our app may use **cookies**, web beacons, and other tracking technologies to enhance your experience. Cookies are small text files stored on your device that help us remember your preferences and personalize your experience. For example, cookies may be used for:

- Authentication: Keeping you logged in.
- **Analytics**: Tracking how you use the app to improve functionality.

You can manage cookie preferences through your device settings. However, disabling cookies may affect certain features of the app.

6. Your Choices

You have certain rights regarding the information we collect about you:

If you request to delete your account, we will remove your personal information from our active databases, though certain data may be retained for legal, accounting, or auditing purposes.

9. Changes to This Privacy Policy

We may update this Privacy Policy from time to time to reflect changes in our practices, technologies, or legal obligations. When we make changes, we will revise the "Effective Date" at the top of the page. We encourage you to review this Privacy Policy periodically to stay informed about how we protect your information.

11. Reviews and User-Generated Content

If you prefer to remain anonymous, we recommend not including any personal information that you do not wish to be shared in your review.

By submitting reviews and ratings, you help other parents in the community make informed decisions, and we appreciate your feedback. However, please note that your reviews or ratings do not constitute any form of endorsement from us, nor do they guarantee any specific outcomes.

12. Creating Profiles

To enhance your experience and allow for personalized features, our app may allow you to create a user profile. By creating a profile, you provide information that helps us tailor the app's services to your preferences. When you create a profile, you acknowledge and agree to the following:

A. Profile Information

13. Third-Party Services and Ads by Google

Our app may display ads served by third-party advertising companies, including Google. These third parties may collect certain information to serve personalized advertisements based on your interests and activities. By using our app, you acknowledge and agree to the following:

A. Google Ads

We use **Google AdMob** (and other Google services) to display advertisements within our app. Google may collect information such as your device type, location, and usage data in order to deliver more relevant ads. This allows us to support the app's development and provide a free service to our users.

A. What Google Analytics Collects

Google Analytics may collect certain information about your use of our app, including:

- **Usage Data**: Information about how you interact with the app, such as which features you use, the frequency of use, and the duration of your sessions.
- **Device Information**: Information about your device, such as device type, operating system, device identifiers (e.g., IDFA, GAID), and browser type.
