# ***Invitation To Bid for The Procurement of General Medical Supplies***

**IB NO. 2023 – 085**

1. *Tondo Medical Center (TMC)*, through the *General Appropriations Act of 2023* intends to apply the sum of **One Million One Hundred Fifty Five Thousand Philippine Pesos (Php1,155,000.00)** being the ABC to payments under the contract for the *Procurement of General Medical Supplies* under *IB No. 2023 – 085*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. *TMC* now invites bids for the above Procurement Project. Delivery of the Goods is required *within the period specified under SECTION VI. Schedule of Requirements*. Bidders should have completed, within *the last three (3) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from *TMC – BAC Secretariat* and inspect the Bidding Documents at the address given below during *Monday to Friday, 8:00AM to 4:00PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **09 March 2023 onwards** from the given address and website(s) below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount specified below*.
