Hi all, Deckals here.

Over the last couple of weeks, I had been put under fire over content that I had liked on my Twitter and discussing topics deemed “NSFW” or “Proship” with R34 artists despite me lacking any indication on my profile regarding NSFW topics such as a 18+ emoji or any regards to the minors that have been following and followed by me. At first, I decided to not make any statement and didn’t take any action... until now when a user in the TOH fandom found out and made a post about it resulting in a massive decrease in followers and unrelated posts getting dragged into it.

Yes, I have been conversing with NSFW and Proship users of The Owl House fandom over the last month and discussing topics related to proshipping in the fandom and yes, I have been liking NSFW artwork, there is no doubt about it.

I don’t really label myself as a proship nor a 18+ user nor put any warnings is because at the time, I didn’t really post/repost that material onto my feed and didn’t believe that such warnings was warranted despite the content that I liked. I have not drawn nor publish NSFW artworks on any of my socials.

I do, however understand the differences between fiction and reality like everyone else. I believe that people should enjoy

whatever ship/fanart/fanfiction they want as long as it stays in the fiction scope and not interfere with real life.

I do not condone the elements of the artwork that I like in real life for obvious reasons.

However, explaining myself and defending myself won't work in this day and age and due to these recent controversies, I have decided to privatize my twitter temporarily and will put the appropriate indicators permanently. This also means that I won't be posting my normal material on that site and instead focus the stuff I do for twitter elsewhere on other platforms.
