

The following is Brian Head Resort's Ski Bike Policy:

- Brian Head Resort accommodates skiers, snowboarders, and riders using traditional or allowed equipment that may include bindings and ski retention devices. Foot passengers or guests using devices without appropriate binding systems or restraining devices are not permitted on lifts or terrain. Recreational devices NOT allowed on Brian Head Resort slopes at any time including, but not limited to, sleds, toboggans, ski scooters, snow skateboards, snowshoes, snow feet & similar devices, snowmobiles, et cetera.
- Exceptions are made only for disabled skiers using specifically designed adaptive equipment that includes a binding, retention device, and pre-installed evacuation rigging for devices attached to the lower torso. If the disabled skier cannot load, ride, or unload the lift by themselves safely, then they must be accompanied by their personal assistant.

WHAT IS ALLOWED:

1. <u>Standard Alpine Ski with Bindings</u>: This is the original design for skis, featuring a middle section that rises off the snow slightly. Must have fixed heel bindings.





2. <u>Standard Snowboard with bindings and leash</u>: Bindings directly connect the person to their board, and Snowboards should have a leash connecting your body to the snowboard to prevent the board from sliding downhill when detached from you.



3. <u>Telemark Skis</u>: The primary differences between telemark and alpine skiing are binding and boots. The telemark binding locks down the front of your foot and has an adjustable cable on the back that is loosened for rolling terrain and tightened to keep your heel down for descents.



- 4. <u>Ski Bikes and Board Bikes</u>: A hybrid approach for downhill skiing. The idea is simple. Instead of putting wheels on a bike frame, you attach a pair of skis.
 - 1. Ski Bikes must be commercially manufactured or a commercially manufactured conversion kit for a mountain bike.
 - 2. Must be equipped with an appropriate retention device to prevent runaway equipment.
 - 3. Ski bikes Must not impede the natural flow of lift operations.
 - 4. Users must be able to know how to load and unload safely.



Board Bikes: Essentially the same as a ski bike, but with one single ski.



<u>Sled Dogs:</u> These devices consist of a pair of flexible ski boots with integrated bases resembling **sled** runners that are approximately the same length as the boot itself. Sled dogs must be manufactured with a metal edge to meet the criteria of approved sliding devices.



Snow Skate Boards: Snowskating is a combination of snowboarding and skateboarding. These boards are designed as a hybrid of the two boards, allowing riders to do skateboard-like tricks in the snow.



- 1. Snow Skates must be commercially manufactured or a commercially manufactured conversion kit for a skateboard..
- 2. Must be equipped with an appropriate retention device to prevent runaway equipment.
- 3. Snow Skates Must not impede the natural flow of lift operations.
- 4. Users must be able to know how to load and unload safely.
- 5. Snow Skates must be manufactured with a metal edge to meet the criteria of approved sliding devices.

WHAT IS NOT ALLOWED:

<u>Sleds/toboggans</u>: A sled, sledge, toboggan, or sleigh is a land vehicle that slides across a surface, usually of ice or snow. Sledding is <u>NOT PERMITTED</u> anywhere on Brian Head Resort property.



<u>Ski Scooters:</u> A device consisting of a low footboard on a single ski, steered by handlebars, used for skiing over snow. Ski Scooters are <u>NOT PERMITTED</u> anywhere on Brian Head Resort property.





<u>Snowshoes:</u> A snowshoe is a footwear for walking over snow. Snowshoes work by distributing the person's weight over a larger area so that the person's foot does not sink completely into the snow, a quality called "flotation." Snowshoes are <u>NOT</u>
<u>PERMITTED</u> anywhere on Brian Head Resort property.





Snowskates/Snowfeet:.

Snowskates/Snowfeet are **NOT PERMITTED** anywhere on Brian Head Resort property.



Snowmobiles: A motor vehicle, especially one with runners in the front and caterpillar tracks in the rear, for traveling over snow (snowmobiles can only be used on resort property by Authorized Personnel). Snowmobiles or any other motor vehicles are **NOT PERMITTED** anywhere on Brian Head Resort property.



ADA EXCEPTIONS TO WHAT IS NOT ALLOWED:

• **Per Brian Head Resort's ADA Policy:** Exceptions and reasonable accommodations are made only for disabled skiers using acceptable adaptive equipment, including a binding and retention device. If the disabled skier cannot load, ride, or unload the lift by themselves safely, then they must be accompanied by their personal assistant.

Approval by Ski Patrol will be required for any guests who need an exception to the Ski Bike Policy.
