Stand with Refugee Women, Resist Attorney General Sessions' Attack on Domestic Violence Survivors!

FIRST, WHAT ARE THE ISSUES?

Decades of progress in domestic violence protections are at risk. In March of this year, Attorney General Jefferson B. Sessions took advantage of a rarely used power to suddenly and inexplicably intervene in the asylum case of a domestic violence survivor, known as [Matter of A-B-](#). The woman at the center of the case, Ms. A.B., had already won asylum (refugee protection) and was ready to begin her new life in the United States – until Sessions stepped in and [assigned](#) her case to himself for reconsideration.

The United States has long stood as a beacon of hope for women fleeing violence and persecution in their home countries. In recent years, in a giant step forward, our immigration courts explicitly determined that a person fleeing severe domestic violence who can find no protection from her own government may be granted asylum.

Advocates have fought hard to win strong legal precedents that now enable women like Ms. A.B. to find safety here.

But that may be about to change.

The Attorney General is poised to overturn these critical precedents and rescind the promise of protection for women and girls fleeing violence at the hands of abusive partners and family members. At a time when violence against women and girls has reached crisis levels, this would be a grave mistake.

Now, more than ever, we need your help! Stand with us and make it clear that you want our country to continue to offer refuge to survivors of domestic violence when they have nowhere else to turn.
