
### 3. Update monitoring data and identified gaps-ENCU.

- More attention is needed also in areas where food distribution will be reduced (as per change from rounds to seasonal distribution, etc) as the risk of an increased number of malnutrition cases- action is needed the sooner
- In areas affected by outbreaks the relation (number of malnutrition cases) is observed
- We anticipate more cases of acute malnutrition in the current quarter and next quarter (till Sept) as all drivers of malnutrition are presence in many areas.
- Q2 and Q3 more acute malnutrition cases are predicted.
- it's anticipated that the monthly admission may reach to 80,000 children in the coming months.

### 4. Presentation of ENCU on the Red Flag monitoring

"Red flag" is a metaphorical expression denoting the occurrence of a problem that needs to be analysed and resolved in order to avoid exceeding the capacity to respond adequately

ENCU has start to do analysis based on increase or decrease (changes) on some key indicators by woreda. This Red flag system will help us to identify problems.



This model proposed by ENUC of using the monthly monitoring data will help to get a clearer perspective on the data by basing the analysis on established thresholds of indicator change under the assumption that these changes show some programme problem, whether it be quality of care, increased case finding, lack of support, etc. For example,

specifically monitoring admissions of children under 6 months of age is relevant and is not done. However, this proposed model has limitations related to accuracy and quality of data, as well as the functionality of the programme, but it is therefore useful for monitoring the quality of care of children under 6 months of age.
