### **Overview**

The EMHRPP (Erasmus Mundus Human Rights Policy and Practice) visiting scholar initiative aims to bring together researchers and professionals from a range of settings and with a common interest in the field of Human Rights Policy and Practice.

This will be both an opportunity to engage with different ideas and research findings in relation to Human Rights, and an opportunity to network with colleagues from a wide range of countries.

There will be a particular emphasis put on what expertise you can bring to support the students studying on this programme.

Scholars and guest lecturers can come from both Programme and Partner Countries and their involvement should bring added value to the master's programme student intake in terms of student-centred teaching/lecturing, research activities, Master thesis support, academic/professional networking, etc.

The participation of high-level scholars/guest lecturers plays an important role in increasing the course attractiveness, and thus the aim is to attract individuals with outstanding academic and/or professional profile to be involved in our master's programme.

### **Procedures and Key Dates:**

Applications should be submitted by e-mail to: EMHRPPUGOT@gu.se

- 1. **Deadline first yearly batch of Visiting Scholars:** <u>10th April</u>. Authors will receive an email notifying them of the results no later than 10th June.
- 2. **Deadline second yearly batch of Visiting Scholars:** 10th October. Authors will receive an email notifying them of the results no later than 10th December.

# **Visiting Scholar Role:**

Bearing in mind the time of their visit stay, below are a range of activities that are performed by visiting scholars in our EMHRPP programme:

- Network with staff and students creating opportunities for further institutional networking and collaboration.
- Take part in activities for engagement with students and staff.
- Contribute to seminars/talks at the institution(s) for students and staff.
- Conduct a short research project and write a report of the experiences and research during the time.
- Act as a critical friend interacting with and supporting students.
- Be invited/encouraged to present a paper on an area related to their area of interest and expertise.



# **Entry Requirements:**

- Proof of academic contribution at a university or educational institution, with the proficiency to lecture at master's Level and in English.
- Publication at academic level
- Professional/academic experience in the field of Human Rights.
- Relevant academic qualifications.
- Outstanding academic and/or professional experience to bring added value to delivery of Erasmus Mundus Masters Course.
- Commitment to actively participate in EMHRPP (the programme) activities.

#### **Duration**

The minimum duration per engagement of a visiting scholar is **four to seven consecutive calendar days (= one week)**. It is not possible to consider eight consecutive days as two weeks. Days of scholar work may include travelling time.

#### **Conditions**

Scholars and guest lecturers can come from the partners of the EMHRPP, as well as from outside the consortium.

# **Financial support**

Scholars and guest lecturers cannot benefit from other EU funding schemes while participating in an EMJMD (Erasmus Mundus Joint Master Degree). The EMHRPP is one example of EMJMD.
