

CIRCULATOR INSTRUCTIONS

NEBRASKA NOMINATION PETITIONS

ROBERT F. KENNEDY JR.

1. EACH PETITION PAGE **MUST** BE PRINTED ON 8 ½" x 11" PAPER, IN LANDSCAPE FORMAT. THE TWO PAGES MUST BE PRINTED ON 1 PAPER, FRONT AND BACK – NO EXCEPTIONS. THE WORDS “THIS PETITION IS CIRCULATED BY A PAID CIRCULATOR” AND/OR “THIS PETITION IS CIRCULATED BY A VOLUNTEER CIRCULATOR” MUST BE IN RED PRINT (**NO OTHER** PART OF THE PETITION MAY BE PRINTED IN RED).
2. YOU MUST BE 18 YEARS OF AGE TO CIRCULATE THIS NOMINATION PETITION.
3. YOU MAY NOT PAY, OR PROVIDE ANYTHING OF VALUE, TO INDUCE A PERSON TO SIGN THIS PETITION.
4. YOU MAY NOT MISREPRESENT THE PURPOSE, OR SUBJECT, OF THIS PETITION TO A VOTER. FOR INSTANCE, YOU MAY NOT SAY “SIGN THIS PETITION TO HELP FEED THE POOR” or “SIGN THIS PETITION TO SAVE AMERICA.” THIS PETITION, AND SIGNATURES PLACED THERON, IS FOR THE SOLE PURPOSE TO PLACE THE NAME OF ROBERT F. KENNEDY JR., ON THE 2024 NEBRASKA GENERAL ELECTION BALLOT AS AN INDEPENDENT CANDIDATE FOR THE OFFICE OF PRESIDENT OF THE UNITED STATES.
5. EACH VOTER MUST PROVIDE – IN HIS/HER OWN HAND:
 - A. THE DATE THE PETITION IS SIGNED; and,
 - B. HIS/HER SIGNATURE; and,
 - C. HIS/HER PRINTED NAME AS IT APPEARS ON THE VOTER’S REGISTRATION RECORD; and,
 - D. HIS/HER DATE OF BIRTH; and,
 - E. VOTER’S ADDRESS AS IT APPEARS ON THE VOTER’S REGISTRATION RECORD; and,
 - F. VOTER’S CITY OR TOWN; and,
 - G. VOTER’S ZIP CODE.
6. IF YOU ARE RECEIVING ANY COMPENSATION, IN ANY FORM, TO CIRCULATE THIS PETITION, YOU MUST USE THE NOMINATION PETITION LABELED “THIS PETITION IS CIRCULATED BY A PAID CIRCULATOR.”

IF YOU ARE NOT RECEIVING ANY COMPENSATION TO CIRCULATE THIS PETITION, YOU MUST USE THE NOMINATION PETITION LABELED “THIS PETITION IS CIRCULATED BY A VOLUNTEER CIRCULATOR.”

7. VOTERS MUST USE A BLACK OR BLUE BALLPOINT PEN TO SIGN THEIR NAMES. TRY NOT TO USE GEL PENS, AS THEY CAN SMEAR – ESPECIALLY IF THE PETITION PAGES ENCOUNTER MOISTURE.
8. AFTER THE LAST SIGNATURE IS COLLECTED, YOU MUST EXECUTE THE CIRCULATOR’S AFFIDAVIT AT THE BOTTOM OF THE 2ND PAGE (BACK SIDE OF THE PETITION PAGE) – IN FRONT OF A NOTARY PUBLIC.

YOU MUST: (1) PRINT YOUR NAME ON THE LINE IN FRONT OF “(Name of Circulator);” (2) SIGN YOUR NAME WHERE INDICATED; and (3) RECORD YOUR CURRENT ADDRESS ON THE LINE NEXT TO YOUR SIGNATURE.

THE NOTARY PUBLIC WILL EXECUTE THE REST OF THE AFFIDAVIT.

9. ORIGINAL OF THE PETITION MUST BE RETURNED TO THE CAMPAIGN – NO COPIES PERMITTED.
