SITE BASED RULES AND EXPECTATIONS

1. All vehicles driven to school must be registered with the school and the student parking permit (hang tag) must be displayed in a location clearly visible from the outside of the vehicle. Vehicles parked without a hang tag will be issued a ticket.
2. Speed limit on school grounds is 10 MPH. The vehicle must be operated in a safe and legal manner at all times.
3. Students are not allowed to loiter in the parking lots or vehicles before, during, or after school hours.
4. Parking in fire lanes, no parking zones and/or restricted areas is prohibited.
5. **Parking in the marked off zones is limited to 3pm on Wednesdays. Vehicles MUST BE OUT of the marked off zone by 3pm on those days or a ticket will be issued.**
6. Violations of rules and expectations may lead to fines, parking boot, or towing as well as law enforcement involvement and school disciplinary consequences.
7. This parking permit is the property of Columbine High School and can be surrendered upon request.
8. **Parking is permitted in the Student Lot only by permit. No parking in the Visitor or Faculty lots between the hrs. of 7:00am and 3:30pm.**
9. I understand that the parking lot is the property of Jefferson County Public Schools R-1.
10. I agree that the car will not be used to transport or store illegal items on school property.
11. I will not use the school parking lot to violate a criminal code or school rule.
12. In exchange for the privilege of parking on school property, I give school officials and/or school security personnel consent to search my car and the car's contents at any time. Any item that violates school or criminal law can be seized at that time.
13. Parking Permits are not transferable to other students or unauthorized vehicles.
14. I understand that violations of these rules can lead to suspension or revocation of my parking privileges, fines, referral to law enforcement authorities and/or school disciplinary actions.

FINES: All parking violations will have a charge of \$30.00

Students have 10 school days to dispute or contest any fines. Failure to contest a fine within 10 days will lead to the imposition of the fine. All fines should be paid within 30 days and it is the student's responsibility to communicate with parents regarding fines.

Jefferson County Schools and Columbine High School assume no responsibility for any damage to vehicles parked on school property or to the loss of any articles contained therein.
