PAYMENT \$

- Payment is through **Paypal** in **USD**, and Paypal handles conversion rates between currencies. An invoice is sent for all commission orders.
 - Clients using Venmo or Cashapp may pay me through **Ko-Fi**
 - Canadian customers may pay USD → CAD conversion with **E-Transfer** at a **2%** discount.
- Payment is required in full before I begin your art.
 - Payment plans are available for orders over 200 USD
- I will only work with commissioners **15 years of age or older**.

WHAT I WILL DRAW ✓

ABSOLUTELY!	anthros / ferals / pets / monster, creature designs
MAYBE	humans / humanoids
NO	complex mechas, extreme gore, hate speech

Highly complex character designs may incur an additional fee. Examples of potentially detailed designs include meticulous colours, spots, and stripes. Similar principles apply to clothing and accessories as well.

- You must either own the characters you are commissioning or have permission to commission art of them. I do not do commercial work, only art for personal usage.
- Light gore (minor blood, candy gore, etc.) and suggestive tones are OK
- If you want your character to be wearing or possessing anything specific, be descriptive and provide visual references of the outfit or object.
- I have the right to decline your commission for any reason.

WORK IN PROGRESS (WIP) 🎨

- I will always send a sketch WIP minimum for general commissions.
- For larger commissions, more WIPs will be shown to you, typically in the lining and colouring phases as well as any specifics I am unsure of how to portray.
- I might not accept changes related to altering my style, for example, how I draw noses.
- Asking for excessive changes to your commission may incur additional fees.

- **Up to three (3)** edits after completion due to some change you'd like made may be requested within the **first month** of delivery. If a month has passed, I reserve the right to reject any edit requests, as with any changes that may be too large to edit without requesting a service charge.

FINISHED PRODUCT & USAGE 🌟

- All art comes watermarked with a minimally-invasive logo/signature.
- Commissioners may share artwork and use it wherever they wish. To post the standalone image online/on social media, please credit me with a direct link to my account on most social media platforms, soaringcory, or to my [website](#)!

If my work is ever seen in this context, please assume that permission was NOT given. Violation of these rules will result in a permanent blacklist.	

TURNAROUND/QUEUE POLICY 🌊

- You can view my queue on [Trello](#) to get an idea of wait times before ordering a commission.
- My turnaround time varies on my schedule but will vary between 1-3 months.
- Orders are not completed in order of payment to prevent burnout. Larger commission types may see slower progress but are worked on alongside smaller headshots for ease of workflow, and each commission queue is always cleared before taking on the next round.

DELAYS/REFUNDS

- Refunds may be negotiated in the event of excessive delays or if I need to cancel the order for any reason. I cannot promise to accept refund requests, but I am always open to discuss alternatives!
- Refund percentages: 100% - processing fee if not started, 50% if sketch is done, and 20% if lines are done. No refunds are given after starting colouring or commission completion.
- Full refunds are permitted if I am excessively **late** with your commission (over 6 months) and have not completed past the **lining** stage.

CLIENT RELATIONS

- I check commission-related messages at least once per business day. Please allow me up to two days to respond to any messages!
- I reserve the right to decline orders from any suspicious or untrustworthy identities.
- I reserve the right to decline orders from returning clients who I found stressful to work with on previous occasion, or a client of status that I feel uncomfortable to be associated with.
- I do not claim to have full knowledge of every character I am commissioned to draw, and do not necessarily share the views demonstrated by the character or the character's owner.
