GENERAL ELECTION INFORMATION

Election Day 2025 will take place on Tuesday, November 4, 2025.

Ballots will be mailed out to all eligible voters beginning October 14, 2025.

To be eligible, voters must be of legal voting age, a citizen of the United States, and a resident of the voting precinct in which they are registered. If you have registered by the specified deadlines, your ballot will be mailed to the address you provided.

Voters can check their registration status, view specific sample ballots, and learn about candidates online at www.vote.utah.gov or call the County Clerk's Office at (435) 676-1100.

If voting by mail, please ensure your ballot has POSTAGE. <u>Please note that there has been a change in state law regarding ballot deadlines this year, and therefore, postmarks no longer count</u>. **TO BE VALID, A BALLOT MUST BE RECEIVED BY THE GARFIELD COUNTY CLERK'S OFFICE ON OR BEFORE 8:00 P.M. ON ELECTION DAY.**

- Tuesday from 10:00 a.m. to 3:30 p.m.
- Wednesday, Thursday, and Friday: 10:00 a.m. to 1:00 p.m.
