## **Mountain Use Policies**

### **Access to Mountain at Your Own Risk:**

Downhill skiing, cross-country skiing, snowboarding, mounting biking, and many other activities that are permitted at HoliMont, contain inherent risks including, but not limited to the risk of personal injury, including catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions; or, surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps; or other persons using the facilities; or, rocks, forest growth, debris, branches, trees, roots, stumps; or, other natural objects or manmade objects that are incidental to the provision or maintenance of our facilities. You should understand the risks inherent in the activity you are undertaking so that you may make an informed decision of whether to participate in such activity notwithstanding the risks. If you are not willing to assume all of these risks and abide by all of these duties, you must not participate in these activities at HoliMont.

If you access the mountain, you do so at your own risk. Snow may or may not be groomed, hazards may be unmarked, visibility may be limited, vehicles and equipment may be present and/or in operation at any time, and lifts may start or stop at any time without warning. Stay away from all equipment and machinery on the mountain. Use extra caution and remain aware of what is happening around you at all times.

**Rescue Response:** Please be aware that there are no Ski Patrol or first aid staff on the mountain outside of the operating hours of the ski area. In case of an emergency, please call 911 and know that response times will be extended.

### **No Mountain Access After Sunset:**

1. For your safety, access to the mountain is only permitted during daylight hours.

2. Overnight stays on the mountain are not permitted.
3. **Stay clear of all grooming operations and equipment!** Snow cats can be anywhere on the mountain at any time – grooming trails, moving equipment and staff, and facilitating snowmaking operations. Cats are equipped with multiple lights, including a flashing yellow beacon for visibility. If you encounter a snow cat, stay out of its path of travel, even if it means leaving the trail you are hiking or getting off of the snow.
4. Winch cats may be operating at any time while grooming is underway. These cats are anchored to the mountain with a steel cable that is several thousand feet long. The cable may be buried or on top of the snow and it can “whip” high in the air, or across a slope quickly and without warning. Stay off of any trail and out of any area where a winch cat is operating.

### **Sledding Policy:**

Sledding on the slopes at HoliMont is not permitted at any time. Members and guests that fail to comply with this policy may face disciplinary action.

### **Backpack/Baby Carriers:**

Children are not permitted in chest carriers or backpacks on the lifts or on the hill.

### **Inverted Aerials:**[\[TW1\]](#) [\[EJC2\]](#)

Unauthorized inverted aerials are not authorized unless under the supervision of Holimont coaching staff in connection with a Snowsports program. An inverted aerial is defined as any aerial maneuver where the participant's heels are above his/her head. HoliMont takes our safety and liability concerns very seriously. Members and guests that fail to comply with this policy will face potential for disciplinary action.

### **Uphill Travel Policy:**

*For your safety, access to the mountain is only permitted during daylight hours.*

HoliMont allows uphill access via hiking, skinning, and snowshoeing during the winter operating season for ticketed guests, members, and passholders. Participants in all of these activities are asked to adhere to the following guidelines and accept all risks associated with uphill travel on an operating ski area:

**For non-members an uphill access pass will be available at any ticket window for \$25/season. Non-members who are not a guest of a member are restricted to weekday use only for uphill access. There is no charge for current members or passholders, however you will have to stop at the ticket window to have your Uphill Access sticker attached to your pass (once per season).**

- 1. All Uphill traffic must happen on the side of the trail. Please stay to the side of all trails while traveling uphill.**
- 2. Uphill travel is permitted during daylight hours only.**
- 3. All snowshoe traffic should travel downhill on the XC Trail Only. Do not attempt to walk downhill on our ski trails or in only shoes or boots.**
- 4. You must remain visible at all times to hill traffic – including grooming equipment and snowmobiles. We highly recommend that you wear brightly colored and reflective clothing.**
- 5. Please leave the dog at home, dogs are not permitted on our slopes.**

### **Cross Country Ski Policy:**

**Lift Service: The ticket office can issue a one trip ticket for one ride up to the top of the hill for cross-country skiing.**

**Our designated multi use trails are groomed occasionally based on snowpack and conditions. Please use caution when traveling downhill and watch for uphill traffic.**

### **Biking at HoliMont:**

**To facilitate the *safe and courteous* use of club facilities, the following rules have been adopted to guide all members, their guests, and the public. HoliMont continues to encourage biking at and around the club, but under the following conditions:**

- 1. All riders must wear an approved helmet.**
- 2. No riding on the downhill slopes during the ski season, whether or not the lifts are running.**
- 3. No riding on the downhill slopes out of ski season, other than on the approved trails.**
- 4. No riding on the property after sunset.**
- 5. We currently allow Class 1 e-bikes on our trails. Class 1 e-bikes are pedal-assist only, meaning the electric motor only provides assistance when the rider is pedaling. These e-bikes do not have a throttle and are limited to a maximum assisted speed of 20 mph.**

6. At this time, we do not permit Class 2 or Class 3 e-bikes on our trails. Class 2 e-bikes have a throttle that can propel the bike without pedaling, and Class 3 e-bikes can assist up to speeds of 28 mph. We believe this restriction helps maintain a safe and enjoyable environment for all riders and minimizes impact on our trail network.

**Drone Policy:**

Due to safety and privacy concerns, HoliMont prohibits the operation or use on or above resort property of unmanned aerial systems, or drones, by the general public—including model aircraft by recreational users and hobbyists—without the prior written authorization from HoliMont. This prohibition includes drones used for filming or videotaping, as well as any drone use by media or journalists operating above or within the area boundaries. This prohibition extends to any devices launched or operated from resort property, as well as any launched from private property outside of the resort boundaries. Please contact a resort representative if you have any questions or if you seek prior authorization to operate any such devices. Any authorized operation of drones on or above Resort property will be governed by Federal Aviation Administration (FAA) rules and regulations, local law enforcement, as well as those policies separately established by this Resort, which may include certification, training, insurance coverage, indemnification requirements, and waivers or releases of liability.

Please note HoliMont does operate a licensed drone occasionally for marketing, events, maintenance, and other operations.

**Pet and Service Dog Policy:**

**On-Mountain use of Service Animals During Winter Season:** No animals shall be allowed on ski terrain or ski lifts during the winter season, unless specifically trained, or is in the process of being trained, for search and rescue work and is under the direct control of Professional Ski Patrol staff.

The use of service animals on ski lifts and ski terrain conflicts with HoliMont's safety requirements necessary for the reasonably safe operation of on-slope activities. These safety concerns include the use of service animals on the slopes that expose the user and other skiers/snowboarders to a safety hazard. These safety concerns are compounded by our facility's high volume of trail use. These safety requirements are based on actual risks and are not intended to be discriminatory in any way.

**On-Mountain use of Service Animals During Summer Season:** Pets and service

**animals are welcome on our grounds and on our hiking trails. They must be leashed and under control always.**

**HoliMont supports the use of trained service dogs during the summer and winter operating seasons but never on ski terrain or ski lifts. All service dogs must meet current ADA guidelines to include, but not be limited to remaining under the direct control of the user always; be house broken; and be trained and utilized for a specific disability approved by ADA regulations.**

**Due to Department of Health regulations, pets are not permitted in any of our dining facilities or chalets.**

**Violations of Policies:**

**Any violation of these policies may involve suspension of your access privileges to the property, the revocation of your membership privileges, lift ticket or season pass, as well as confiscation of any prohibited equipment, and may subject violators to any liability for damages, including, but not limited to, damages for trespass, and physical injuries to persons and/or property, as well as legal fees. Violations committed by members of the club shall be referred to the disciplinary committee/executive committee and subject to review by the board of directors.**
