- Questions/Concerns raised:
 - Landscaping
 - Are the landscapers going to take care of the leaves?
 - Yes. It is cheaper for them to come out less. So, this will probably be done in mid/late November. This is when they will stop cutting.

- There is a tree in a common area on Summerwood that was planted by a homeowner that is dead.
 - The Board will look and all tree service.
 - Remind owners that they can't plant anything in a common area.
- What about snowplowing?
 - o The board is arranging for upcoming bids for this.
- Erosion and drainage problems in the Community
 - o County Grants will take care of some of the issues.
 - Knottwood is going to fall under this.
 - It would cost over \$300K to fix. Have to rebuild the entire infrastructure. And there are state wetlands behind.
 - o Unfortunately, there has been a lot of county turnover recently.
- Potholes on Summerwood
 - o Unfortunately, the weather has cooperated. David McAteer is prepared to tackle this himself. But we need 3 dry days before patching. Then 3 dry days after. Just hasn't happened yet.
 - We are looking for volunteers to help David with this project.
- Community Trashcan
 - Tami Hook and her husband have been taking it upon themselves to empty this trashcan (on Kimwood Rd near Driftwood). But they are no longer able to do this.
