Privacy Policy

This Privacy Policy ("Policy") is formulated byKenan Yilmaz ("we", "us" or "our") in relation to the use of *Tap Bloom: Color Connect* ("the App" or "the Service"). This Policy is intended to explain how we will collect, use, share and otherwise process personal information.

A. When you use or interact with the App, we may collect the following information about you:

- When it is necessary to improve the App.
- When it is necessary to comply with legal or regulatory obligations.

D. We may share your personal data with third-party service providers who assist us in providing services to you.

We may also disclose your personal data if required by law, or if we believe that such disclosure is necessary to protect and defend our rights, property or personal safety. E. You have the right to exercise the following rights with respect to your data:

- To know what kind of personal data we hold about you and to obtain a copy of that data.
- To request that your data be updated or corrected.
- To request that the use of your personal data be stopped.
- To request that your personal data be deleted.

F. We protect your personal data through technical and organizational security measures to minimize the risks of data loss, misuse, unauthorized access, unauthorized disclosure and tampering. To this end, we use network security services and data encryption, among other means, and implement physical access restrictions to our data centers and logical access controls for data and system access.
