

FIBA Rules Refresher Level 1 – 2022/2023 – answers

For the sake of consistency, 'Team A' is the (initial) offensive team, 'Team B' is the defensive team. A1 – A5 and B1 – B5 are players; A6 – A12 and B6 – B12 are substitutes.

<u>IMPORTANT NOTE</u>: Please answer the exam questions according to the 2020 FIBA Rulebook and Interpretations – i.e. do not apply any provincial/conference/league modifications should they exist in your province.

1.	Υ	Dribbler A1 is charged with a technical foul. B6 requests to become a player to attempt the free throw. Shall the referees grant this request? FIBA Rule Book Article: 19.2 36.3 FIBA Interpretations Article: 18/19-13
2.		With 21 seconds remaining on the shot clock A1 dribbles in his backcourt when B1 is charged with a technical foul. Select the correct ruling: A) Shot Clock = 24 / Backcourt Count = New 8 seconds / Team Foul = Yes B) Shot Clock = 21 / Backcourt Count = 5 seconds / Team Foul = Yes C) Shot Clock = 14 / Backcourt Count = New 8 seconds / Team Foul = Yes FIBA Rule Book Article: 29.2.1 28.1.3 36.3.1
3.	N	After a violation by team B a backcourt throw-in by A3 is deflected by B3. The ball bounces freely in the backcourt for 2 seconds before it is controlled by A4. Is the referee correct in starting an 8-second count when A4 takes control of the ball in the backcourt? FIBA Rule Book Article: 28.1.1
4.	N	With 45 seconds on the game clock in the fourth quarter thrower-in A1 has the ball in her hands when A3 contacts B3 on the playing court. A foul is called on A3. Shall A3's foul be ruled an unsportsmanlike foul? FIBA Rule Book Article: 37.1.1 FIBA Interpretations Article: 37-3
5.	N	A1 in her backcourt passes the ball to A2 in her frontcourt. A2 touches but does not control the ball which then returns to A1 still in her backcourt. Has team A caused the ball to be illegally returned to its backcourt? FIBA Rule Book Article: 30.1.1 30.1.2 FIBA Interpretations Article: 30-13
6.	Υ	A2 comes off a screen set by A1 on B3 and attempts a three-point shot. After the release of the ball on the shot A1 commits a foul on B3 and then the ball enters the basket. This is Team A's 5th foul of the quarter. Is the referee correct in counting the 3 points for team A and then awarding two free throws to B3?

7.	N	A1 is injured and the game is stopped. A1 is not able to continue to play immediately and the referee beckons in a substitute for A1. Team B then requests a timeout. At the end of the timeout A1 is recovered and requests to re-enter the game. Shall A1's request be granted at this time? FIBA Rule Book Article: 5.7 FIBA Interpretations Article: 5-14 5-15
8.	N	During a free throw does the ball become live when the free-throw shooter releases the ball on his shot? FIBA Rule Book Article: 10.2
9.	Υ	A1 is in the act of shooting when A2 fouls B1. A1 finishes his shot with a continuous motion. When the foul is called shall the ball become dead immediately? FIBA Rule Book Article: 10.3 10.4 FIBA Interpretations Article: 10-1 10
10	N	A1 and B1 commit technical fouls against each other at approximately the same time. By rule is this considered a double foul? FIBA Rule Book Article: 35.1 34.1.1 FIBA Interpretations Article: 35-1 35-2
