DISCLAIMER!!!

Before creating new payment accounts or online content for NSFW, do the following...

- Before you start, **please check** which sites are blocked, as age verification bills and other laws might have been enacted. I recommend following the news and research before considering joining or entering. **Bring a proper and fully functional**    , **and change your DNS settings.**
- File a sole proprietorship and a business name different from your online NSFW handle. This is a requirement to open a business account with a payment processor, which allows you to protect your personal information from customers.
- Use invoices for commissions.
- **DO NOT** accept "pay as friend/family."
- If you are running a business, **DO NOT** avoid any taxes.
- Use vague item descriptions on invoices and disable consumer comments.
- **DO NOT EXPLICITLY** label commissions and products as **18+, R18, Adult** (*which also includes hentai, yaoi, yuri, futa, etc.*) or **NSFW**.
- Rotate through multiple Payment Processors in case one suspends your payments for any reason. (There are process payments that I recommend on the list.)
- **NEVER** keep large amounts on a single payment site/payment processor. Treat these services like banks by withdrawing the money either weekly or bi-weekly.
- For protection against ads and such, make sure to have Google, Opera, Edge or Firefox and download the following extensions: [uBlock Origin](#), [Popup Blocker Strict](#), [Clear URLs](#), [Privacy Badger](#), and [Norton Safe Web](#).
- For extra security, make sure to have a strong   . I recommend using Mullvad, i  , or Proton   .
- If you are using scripts (i.e. Tampermonkey, Greasemonkey and Violentmonkey), please use them, as some scripts might invade your privacy.
- **ARCHIVE ALL** your work and save it in a high-capacity USB Hard Drive or Desktop HDD backup (or a "book").

Places to Take Caution or Avoid (NSFW):

For those who want to film, produce, buy, sell (either physical or online) or attend places that accept certain content without the fear of getting in trouble (i.e. free-speech, uncensored content, NSFW, promote certain fetishes/kinks), AVOID certain areas. There are places where anti-porn, privacy and other laws have been passed.

The information is taken from [Comparitech](#) and [WorldPopulationReview](#). As mentioned, this document is still in development, so I will list as many countries, states, provinces, etc., as best as possible.

*For selling 18+ items physically, such as at conventions and bookstores, **make sure to use the recommended payments (Read “Disclaimer” and “Recommended Payments”) or cash. Cash would be the safest bet.***

*Likewise, you can check out **XBIZ, AVN Media Network, BugBug, EroEroNews, The Free Speech Coalition, Niche Gamer, Lewdgamer, SpicyGaming, NookGaming, SexTechGuide, TheP*rnDude, EroEroMedia, Reclaim The Net, and 30r3ntFr3@k.***

*I also recommend using a very trustworthy and strong **VPNS**. (Please read **VPNS** via Guide and Tips.)*

As of recently, the only countries that have little to no censorship are most of South America, Taiwan, Mexico, Switzerland, Norway and Canada. However, that can change, especially with Canada.

North America

Canada

- Selling and possessing p*rnography is not banned (but to some extent)
 - From [October to December 2007](#), certain H-Anime titles were prohibited from importing (This could explain why certain adult stores now have little to no H-Anime DVDs)
- **VPNS** are not banned
- Torrents are prohibited or restricted
- **As of May 2025, Canada is proposing their own age-verification law, [Bill S-209](#), which claims to “protect” young children from exposure to pornography. However, as evident**

with the UK and parts of the US, concerns regarding the invasion of privacy and potential breaches were raised.

- First reading from the Senate was completed on **May 28, 2025**
- Second reading in the Senate was completed on **June 12, 2025**
- As of **October 2025**, Committee Consideration is in progress with their seventh meeting held on **October 9, 2025**.

United States

Laws and Other Bills

- **The [REPORT Act](#) has been passed and enacted**
 - ***“Current law requires online service providers to report content known as child sexual abuse material (CSAM) to the National Center for Missing and Exploited Children’s CyberTipline. Failing to do so can result in a fine of up to \$150,000.***
 - ***The REPORT Act increases mandatory reporting requirements and fines: \$600,000 for small organizations and \$850,000 for large ones on the first offence. Subsequent violations could incur fines of up to \$1 million.***
 - ***Allows electronic communication service providers to preserve CyberTipline reports for over a year. Reports can only be preserved for 90 days.”***
- As of **March 7, 2024**, New York representative Alexandria Ocasio-Cortez is in partnership with [NCOSE](#) (one of [the most notorious anti-porn organizations](#)) to introduce the **DEFIANCE Act**, which targets [“nonconsensual, sexually-explicit ‘deepfake’ images”](#).

- When asked about NCOSE and its reputation in its anti-p*rn campaign, Ocasio-Cortez's chief of staff, Mike Casca, [declined to answer](#).
- As of **September 24, 2024**, the House Committee on Emergency and Commerce revived the **KOSA** bill (Kids Online Safety Act)
 - This bill would not only investigate websites that cause children and teens mental distress, but also **SUE** them.
- [PROJECT 2025](#) (Do we need to explain more?)
- [SCREEN Act 2025](#)
 - Platforms that create, host, or distribute graphic content must use technology to verify users' ages and block minors from accessing such content.
 - The Federal Trade Commission (FTC) is responsible for enforcement. It will conduct audits and enforce penalties for noncompliance.
 - Platforms can contract third parties for age verification, but remain liable for non-compliance.
 - Platforms must implement data security measures and limit the retention of verification data, as breaches could lead to lawsuits or fines from the FTC.

Mexico

- No restrictions are given to NSFW content
- Restricted messaging and VoIP apps
- (V)(P)(N)(S) are not banned or restricted
- Selling, possessing and producing p*rn is legal
 - **HOWEVER**, filming p*rn that involves minors or without a person's consent will result in 7 to 12 years in prison AND a fine of up to 60,000 pesos (Approx. \$3200)

Central America

The Bahamas

- Forbids the production and distribution of p*rn
 - **HOWEVER**, their enforcement is more relaxed compared to other strict countries, and they do not usually enforce them
 - Ironically, they have p*rn on television

- Restricts online p*rn
- Restricts V(P)(N)(S)

South America

Europe

United Kingdom (UK)

- On October 26, 2023, the Online Safety Act (OSA) was passed, allowing the Secretary of the Senate to control and suppress online content that would be deemed “harmful” to children.
 - This also allows OfCom to block and filter websites under that law.
 - OSA also includes detecting apps, including end-to-end encrypted messengers, to detect any signs of CP and other illegal content.
 - Age Verification was in effect starting July 26, 2025
 - P*rnographic sites were not only blocked as various websites and apps, including Twitter, Discord, and Reddit, require users to verify by providing ID verification, while some require facial biometrics.
 - Other sites, such as Wikipedia and LGBTQ+ sites, were also blocked as a result
- Backlash from the UK and Overseas became overwhelming, with many criticizing the law for invasion of privacy, encryption and freedom of speech.
 - A UK petition was made in response to the backlash, with over 510,000 signatures (and counting...) demanding repeal of the Online Safety Act.
 - Despite achieving the required signatures, the government responded that they are doubling down on repealing the law.
 - The backlash resulted in a high usage of VPN services, which the government requested people not to use.
 - Rumours spread that the UK is considering restricting VPNs as YouTube is implementing AI to detect underage users in the US and blocking those who use VPN to bypass it.

- Additionally, TikTok is implementing its age verification check, with people speculating that it's due to the UK's age-verification law.
 - Additionally, certain users were able to bypass the age verification system using screenshots of realistic video game characters and AI.
- Various political figures in the UK responded.
 - The Labour MP admitted that the sole purpose of OSA was not to protect children, but also to prohibit adults from breaking the "status quo" (i.e. Discussion on mass migration).
 - Prime Minister Kier Starmer claims that he is not censoring anyone, despite showing otherwise.
 - Secretary of State for Science, Peter Kyle, accused those who fight for free speech of being on the "predators' side".
- Wikipedia vs. OSA
 - The Online Safety Act blocked Wikipedia, resulting in its operator filing for court case.
 - The Wikimedia Foundation sued the London High Court, alleging that allowing age verification could entail fewer UK users to access their site.
 - However, on August 11, 2025, Judge Jeremy Johnson dismissed the lawsuit.
 - Wikimedia can file another one, should OfCom conclude that "[Wikipedia is a Category 1 service](#)".

Africa

Iran

- NSFW content is **strictly** banned and restricted.
 - **HOWEVER**, (V)(P)(N)(S) are not.
- Unable to view Western Social Media such as YouTube and X
- News is heavily censored due to the influence of the government

Asia

China

- WeChat is an exclusive app that has zero end-to-end encryption and enables third parties to access messages.

North Korea

- NSFW content and ㊄㊐㊒㊔ are **strictly** banned and restricted.
- Unable to view Western Social Media such as YouTube and X
- News is heavily censored due to the influence of the government
- Shuts down messaging apps, allowing them to use alternatives that are made and enforced by the government
- Sailing is banned

South Korea

- NSFW content is strictly banned and restricted, but not ㊄㊐㊒㊔.
- Sailing is banned

Japan

- **Since 2024, due to various issues involving global credit card companies (Specifically VISA and Mastercard) and laws from overseas regarding AV, ecchi and h-content, Japan has taken drastic measures.**
 - These measures involve blocking sites overseas, censoring tags and words, restricting content overseas, blocking overseas credit cards or banning content altogether.
 - This also includes various Western sites such as AmiAmi, Denpasoft, and Shopify, with global payment methods suspended.

- However, the House of Councillors, Yamada Taro, alongside various content creators, including Yoko Taro (Game Director), Ken Akamatsu (Author, Politician), and Hideaki Anno (Anime and Movie Director), expressed their concerns about the ongoing censorship.
- **While NSFW content is acceptable, they have to censor genitals due to Japan's law.**
- **VPNS** are not banned or restricted
- Websites including FANZA, Getchu and certain content such as Pixiv are blocked overseas due to North American, Australian and UK laws. It is possible to bypass it via **VPNS**.
- Sailing is banned and restricted, yet their definition of sailing is questionable (i.e. mods, streaming gameplay, etc.)
- As of [June 2022](#), an AV law was passed in response to Japan's new age of adulthood (Formerly 20, now 18).
 - People aged 18 and 19 are now engaged in adult activities, including working in AV productions.
 - To tackle this, the Liberal Democratic Party and *Komeito* proposed a law that forces young people and AV companies to do the following:
 - AV companies must have a signed contract and explain their expectations for their performers. Failure to do so results in fines and/or prosecution.
 - Participants have the right to end their contract for a full year after production wrap-up.
 - Production would not start for a month after signing a contract
 - A company cannot release the video four months after production
 - Complaints from groups that protect women and children, and AV actors
 - Protection groups argued that the law would reinforce the sex industry in national law and give the AV public respect.
 - AV actors are concerned that it takes work away from actors and that legitimate productions go the extra mile to obtain consent at the time of signing.
 - While the law is beneficial for the most part, actors are skeptical about it being too vague and demand changes.

Oceania

A Letter to all NSFW Creators...

I already made a [statement](#) on Twitter (or X as it is now called) expressing my thoughts and concerns, so if you want to share my post, then by all means, go for it. However, for those who missed it, here is my full statement on the matter...

"Before I state my thoughts, I wanted to address that this is not meant to scare anyone, but more on my concerns and what we should do afterwards, so bear with me. Keep in mind that what I am going to say does not mean it's the end of the world for all of us, as we are trying our best to continue to make a living, despite going through tough times. That said, here I go..."

With the whole Gumroad and PornHub situation coming to light, I want to address that this whole ban is nothing new since there is a deeper lining as to why this is currently happening (or at least based on what I'm following).

Long story short, anti-porn organizations (regardless of political, religious, moral or social mindsets) complain about what is being directed to the corporations. Thus, leading to the banning of NSFW content. It has been like that even before the Internet became widespread and accessible.

However, it has become more egregious than ever with the PornHub lawsuit that took place from the late 2010s to the early 2020s. Since 2021, credit card payments began to "regulate" pornographic content that is deemed "illegal" and/or "obscene".

Now, on paper, it makes sense given how concerns involving IRL CP, consent, blackmailing and revenge porn have been an issue since the early days of the internet. However, the keyword here is "IRL," which means "In Real Life," so you would think that they would only track down and remove these types of content, right? For us, it would have been a godsend.

Unfortunately, banking companies (Mastercard, VISA, PayPal, etc.) are afraid knowing that these anti-porn organizations will continue to go after them regardless of the situation OR that they don't want to associate themselves with "illegal" content.

This is why you see sites like Patreon, eBay, and currently, Gumroad that are heavily affected by it by removing "obscene" content, kinks, fetishes and subcategories in FICTIONAL content (monster, family, love potions, etc.). Sometimes, it's even NSFW altogether.

Even if they are not banned, sites would demand that creators make some alterations so that they can be approved online. That, and the fact that you would have to give them your legal identity by showing your government-approved ID before anything can pass through. Why? It's because they do not want to take that risk.

(It does not help that SESTA-FOSTA was signed in 2018, which resulted in messes such as the infamous Tumblr Ban, and more recently, with the upcoming KOSA Bill.)

This also expands to international stores that heavily rely on these processes. Pixiv FanBOX and Getchu are perfect examples, as these changes also affect them. They cannot sell products that are considered "obscene" or "illegal" in America unless they either alter certain content, censor words, or remove them altogether. So for anyone who is into ravishing tentacles, or fictional non-con content over wholesome and vanilla content, then you are in tough luck.... (I feel you BTW...)

I don't want to appear as a "fear-monger" as some claim in the past, but I hope with the current bannings and restrictions, people are starting to open their eyes, follow the pattern and prepare themselves for the future of NSFW content.

As mentioned earlier, this is not the end of the world, as there are alternatives that we can migrate into, but that too can disappear sooner or later. This is why I encourage people to not only create a lot of backups and archive ALL of their stuff, but also take REAL action through various means, even if it means fighting against the system in hopes that we don't achieve a potentially corrupted and narrow-minded society, or I would like to call it, "The Shimoneta Dystopia".

*As for the future of the surreal comedy series, **Fine Fictional Men**, I am going to talk with my team about how we can try to bypass any current and potential "regulations" while finishing my research, dealing with family finances and taking care of my young sister (not Candy-Chan, but my IRL sister). I was thinking of making new terminologies and phrases which would help...*

However, I felt that this alone is not enough, so we need to think of more ideas to fight against the system and hopefully for all of us to make a decent living.

Anyway, I hope everyone is still going strong despite the boundaries and remember to keep fighting for your rights, just as long as anything you do is not illegal IRL.
