Parental and Family Engagement Policy

MISSION STATEMENT:

The mission of the Teague ISD is to educate to the fullest extent possible all children attending our schools. We will strive to do this through quality of instruction, equity for all students, and accountability and improvement of our instruction. All students will develop essential academic skills and knowledge based on which to build life-long learning.

PART I. GENERAL EXPECTATIONS

Teague Elementary School has worked in collaboration with parents to develop the Parental Involvement Policy (PIP). Annual Title I Parent Involvement Meeting:

Reg. 71710, December 2, 2002) by sending a letter home.

Teague Elementary School will provide materials and trainings to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by: Participating in and informing parents of district Parent Education classes

- Providing resources relation to their child's education
- Availability of the Parent Engagement Liaison, Counselor and Administrators
