Meeting was called to order at 7:05 by Vice President Melanie Hallows. Members present :Melanie Hallows, Becca Gardner, Christa Schott, Amanda Gustafson, Jessica Clark, Mary Grace, Ann Gardner. Leslie LaBarte Seneca District Consultant was present on zoom.

- Motion to approve June minutes was made by Christa Schott 2nd by Becca G. Minutes were approved.
- Public Comment: Risha Johnson and Bill Robinson attended to discuss the new library lighting, they are concerned that the exterior lights are too bright on their house. They would like the lighting to be dimmed, Mary Grace told them the lights have been angled down as far as they will go, but we have dimmer covers to put on them. They also want the free WiFi turned off at night and the interior library lights turned off, Mary Grace and Christa Schott explained to them 24/7 WiFi is a state standard of public service and people coming home from work like to use it. The interior lights are security lights. The Board thanked them for coming in and said we will work on making adjustments to the exterior lights (adding dimmer covers).
- Building and Grounds: new outside lighting was added to the parking lot, entrance, and flagpole.
 Lights will come on at 6 pm and go off at 10 pm. Will put dimmer covers to soften the LED lights.
- Baxter's PHE is fixed unit 1 of the HVAC system: the circuit board failed. Unit 3 outside will need a new blower next spring.
- Vice President's report: we need a District Advisory Council (DAC) committee member. Membership
 is on a 3 year rotation and there is only about a year left for SWS. Mary Grace is the current DAC
 President.
- Directors report: 2023 a possible 17% increase in State aid. We will need to meet their criteria. Quote from FSC systems is 1,189.00 to hook up our internet. A motion was made by Jessica Clark 2nd by Becca Gardner to hook up the internet with FSC system, motion carried. 8/15 Eldred Borough Council meeting went well, they want to stay in the library's service area and will discuss the amount of their LFE at their next scheduled meeting in September. Otto Township has not responded to the library's letter sent in November 2021 or emails and phone messages left in 2022. Leslie LaBarte will begin the process of removing Otto Township from the library's service area. It is expected that by January 2023 Otto Township residents will have to pay an annual fee for a library card and will lose access to District services (ILL, OverDrive, databases, etc). Mary Grace will be attending the PaLa Conference October 16-19 (Harrisburg): need a budget of: 1,150.00. Motion was made by Christa Schott 2nd Jessica Clark to approve travel expenses. Motion was approved. Annual library dinner auction will be November 5th at Star
