**Keywords:** 3-6 words, written in alphabetical order, sentence case, justify, regular, font Book Antiqua and font size 12. Each keyword is separated with a semicolon (;).

### **INTRODUCTION**

**(UPPERCASE, LEFT, BOLD, BOOK ANTIQUA, FONT SIZE 12)**

The journal format consists of 2 columns and is written in MS Word, page size A4, 1 space, sentence case, justify, regular, book antiqua font and font size 12. Margin size is 3 cm, for left, right, top and bottom margins. The distance between the columns is 0.6 cm. Margin for header and footer is 1.25 cm. The text at the beginning of the paragraph is indented 1 cm (format on tab). Articles consist of a minimum of 10 pages and maximum of 15 pages.

The introductory section includes background, objectives, explanations of related research that

have been published previously and state of the art. In addition, the novelty and specifics of your research are also explained. Quotations from references or bibliography use the format (Author Name, Year) for example (Triharyanto, 2016) or (Triharyanto et al., 2016). Foreign language terms and mathematical symbols are written in italics. In the introduction, tables, photos/pictures, numbering, and bullets are not allowed. Introduction should not be more than 2 pages.

This section describes the research data accompanied by relevant discussions and citations. The discussion is not a description of the table/figure.

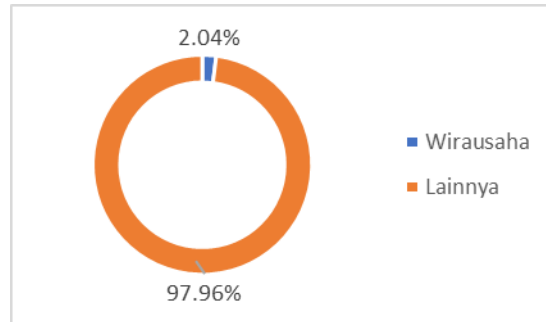


Figure 1. Figur title (Sentence case, center, regular).

References must **not use website sources and anonymous sources** and use at least 15 sources.

References use primary sources from journals, books, or proceedings and **the last 10 years**. References are written in Justify, Font Book Antiqua 12pt **using Mendeley or other reference tools in APA 7<sup>th</sup> edition Style**. Provide the URL/DOI address of the journal/proceedings/books. **Must cite at least 2 article published in the Jurnal Kewirausahaan dan Bisnis.**
