

Premium Sender Private Policy

Website Visitors

Like most website operators, Premium Sender collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Premium Sender purpose in collecting non-personally identifying information is to better understand how Premium Sender visitors use its website. From time to time, Premium Sender may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Premium Sender also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on our blog. Premium Sender only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that blog commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to Premium Sender Website choose to interact with Premium Sender in ways that require Premium Sender to gather personally-identifying information. The amount and type of information that Premium Sender gathers depends on the nature of the interaction. Those who engage in transactions with Premium Sender are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Premium Sender collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Premium Sender. Premium Sender does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

Premium Sender may collect statistics about the behavior of visitors to its website. Premium Sender may display this information publicly or provide it to others. However, Premium Sender does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Premium Sender discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on Premium Sender behalf or to provide services available at Premium Sender website, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using Premium Sender websites, you consent to the transfer of such information to them. Premium Sender will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, Premium Sender discloses potentially personally-identifying and personally-identifying information only in

response to a subpoena, court order or other governmental request, or when Premium Sender believes in good faith that disclosure is reasonably necessary to protect the property or rights of Premium Sender, third parties or the public at large. If you are a registered user of a Premium Sender website and have supplied your email address, Premium Sender may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Premium Sender and our products. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Premium Sender takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Premium Sender uses cookies to help Premium Sender identify and track visitors, their usage of Premium Sender website, and their website access preferences. Premium Sender visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Premium Sender websites, with the drawback that certain features of Premium Sender websites may not function properly without the aid of cookies.

Business Transfers

If Premium Sender, or substantially all of its assets, were acquired, or in the unlikely event that Premium Sender goes out of business or enters bankruptcy, user information would be one of the assets that is transferred or acquired by a third party. You acknowledge that such transfers may occur, and that any acquirer of Premium Sender may continue to use your personal information as set forth in this policy.

California Privacy Rights

If you are a California resident, you may have certain additional rights. California Civil Code Section 1798.83 permits you to request information regarding the disclosure of your personal information by us to third parties for the third parties' direct marketing purposes. California Business and Professions Code Section 22581 permits registered users who are minors to request and obtain deletion of certain posted content.
