

As my client, you *automatically* agree to the following conditions upon commissioning me for artwork. If there are any questions or concerns, feel free to email me at smash.rabbit@gmail.com.

- All prices are in **USD** and non-negotiable.
- As always, by commissioning me, you *automatically agree* to allow me to repost and/or redistribute your commission (my art) as I so choose, unless otherwise requested *within reason*.
- I reserve the right to refuse commissions from anyone I choose for any reason.
- I reserve the right to cancel a commission partway into its progress and refund the client's money *partially or in full* depending on how far along the project is.
- If a client becomes unruly or abusive during the commission process I will cancel the commission, refund fully or partially their payment and end all business communication with said person in the future.
- **Process:** (This applies to standard commissions only which are currently closed, not slave streams) A loosely sketched iteration initiates the commission. Until that point, the commission is considered **In Queue**. **Payment is NEVER required until the initial sketch process is done** (I make an exception for commissions accepted at cons, where I do require payment up-front). At that time, a watermarked, shrunk sketch will be emailed to you for approval, at which time payment will be requested *via Paypal*. Progress will not be furthered along until payment is received. When payment is received all iterations thenceforth will have no watermark and be full-sized, and the commission will continue as normal.
- The client will receive all iterations of the commission as it progresses, e.g. sketch of the commission, ink of the commission, coloring works in progress, etc.
- If payment is not received at the initial sketch level mentioned above, I will end all business communication with you and blacklist you. **NOTE:** This is only if I do not get **ANY** sort of response within a reasonable amount of time, or if you appear to be "stalling" on payment. This instance is rare as well.
- In extreme cases of non-payment or abusive communication I will be forced to "report" about an uncooperative client on the LiveJournal community [Artists Beware](#). I do not tolerate dishonesty or maliciousness.
- If for any reason I have doubts about your credibility and reliability as a client, I will request payment up front (the exception to this is commissions accepted at cons,

where I do require payment up front). This is a **rare occurrence** and will **not** affect most, if not all clients. Clients without prior commission history or are recent registrants to FA/SF/IB/etc. may fall under this requirement.

- **In the event that an edit or change is required in any commission:** If there are any changes that need to be done in any commission, there will be a small charge associated with each change. **Be sure you know what you want and clarify such in the beginning. I will allow a couple of freebies at my discretion.** A charge for changes requested on a commission may vary from \$5 to \$30, but may be adjusted where appropriate. **Not all changes require additional fees** and will be decided at my discretion. Most minor changes *do not* warrant the additional cost, but this fee is designed to compensate for excessive time and effort spent on edits and is only intended for commissions with multiple edit requests. **Only in the event that excess edits are requested will I start charging for them.** **This does NOT apply if the edits or changes requested are a result of my own fault,** such as in the event of me having missed or omitted a detail by accident, or due to a communication error on my part.
- Please note that if your character is more complex than the average character, I have the right to add an adjusted surcharge for laborious or complicated designs depending on its complexity. This won't be necessary for the majority of characters, so most people won't have to worry about this.
- **I will not accept commissions involving the following:**
 - Watersports
 - Scat
 - Babyfurs
 - Diapers
 - Cubs
 - Breath control
 - Asphyxiation/Suffocation
 - Gore/Mutilation
 - Snuff/Death
 - Inflation
 - Tickling
 - Pregnancy/Mpreg
 - Hyper

HOWEVER: I would be willing to accept commissions involving the above subjects by charging triple price for them, depending on which ones.
