#### Introduction

The digital divide has widened since the COVID 19 pandemic in low-income immigrant communities. "Throughout the pandemic, many districts have looked for ways to expand technology access for all students, including language learners and immigrant families" (Breiseth, 2020). Closing the digital divide is crucial now more than ever as we move into a digital era at Alianza Bilingüe School District. This document establishes three instructional technology specialists (ITS) proposals for the 2022-2023 academic school year. The purpose of these positions is to aid teachers in further developing their use and implementation of technology in the classroom and provide additional support during technology troubleshooting.

## **Job Descriptions**

Frazier & Hearrington (2017) developed a technology coordinator handbook in order to tackle the lack of information and resources that exist for technology leaders further assisting technology coordinators in schools. Based on the school district demographics, the titles ranged from manager, specialists, director and coordinator. However, regardless of position or title, "technology coordinators perform a variety of responsibilities more or less similar to other positions in a district-level instructional leadership role" (Frazier & Hearrington, 2017).

The Alianza Bilingüe School District is in an urban school district, the instructional technology specialist (ITS) position is similar to other nearby school districts with large student populations. The three sections introduced will demonstrate three job positions for elementary, middle and high school in Alianza Bilingüe District. The educational technology implemented varies depending on grade levels. Technology coordinators must provide grade appropriate technology implementation in order to align with the curriculum and meet student's in their suitable cognitive developmental stages.

**Elementary School Instructional Technology Specialist** 

The Alianza Bilingüe School District Elementary school uses many technology devices.

In kindergarten through second grade students have individual Ipad carts while in third and

fourth grade, students have chromebook carts. All students have access to an individual device.

Throughout the district, every classroom has Promethean boards and classroom printers. Each

teacher is given a district laptop that is given at the beginning of the year and collected toward

the end of the school year. Students log into different instructional apps using Clever. Through

Clever, students can access their teacher's google classroom, powerschool for grading and

scheduling and daily instructional programs such as Lexia learning which promoted literacy and

language development for English language learners and Amplify, the latest newest English

Language Arts program.

## **Policy and Procedural Manual**

This Policy and Procedural Manual was developed for Educational Technology

Coordinators in the Alianza Bilingue School District for elementary, middle and high school.

The manual provides information on educational technology coordinator's evaluations,

observations and responsibilities.

## Salary, Benefits and Work Schedule

Technology coordinators are expected to follow protocol and the needs of the school district that they are serving. Although an educational technology certification is only required in high school, most school districts prefer and are looking for candidates that have the most educational credentials. The educational technology coordinator must work and report to the director of the educational technology department for the Alianza Bilingüeschool district. The position is a 12 month position. In the United States, average salary for technology coordinators

is about \$65,000 a year although this salary varies depending on the candidate's experience in the field and the guidelines of each district.

#### **Evaluation & Observation**

The instructional technology specialist will be evaluated by a director, principal, supervisor, or other certified administrator or supervisor using the Charlotte Danielson's Framework for Teaching (2011) for instructional specialists. Due to the fact that the role of technology coordinator is not like a classroom position, the technology coordinator will be responsible for creating a professional development workshop per semester that should be completed at the end of the year based on the needs of the assigned schools approved by the director of technology.

The technology coordinator will submit a self-evaluation showing effectiveness in planning and preparation, environment, delivery of service and professional responsibilities with a grading scale of unsatisfactory, basic, proficient, distinguished (Appendix A). Using the Danielson Rubric will help make sure everyone is implementing educational technology in unison to assure an effective instructional technology experience at all schools and for all students.

## Job Expectations and Responsibilities

The instructional technology specialist is in charge of the technology of each building. In their job description, all ITS are required to establish and promote high academic standards for students and staff and serve in the leadership team to support school district programs and services. Moreover, they are to assist in the recommendation of different types of programs that the school makes and interpret these programs and policies to staff, students and the district's community. Frazier & Hearrington state that having an understanding of how and when to

implement pedagogical supports and instructional design knowledge on the impact of technology is crucial.

Lastly, instructional technology specialists must be able to analyze Alianza Bilingue's district data and collect, prepare and coordinate district, state and federal reports that involve any educational services in schools. Furthermore, they must be able to thoroughly analyze and interpret formative and summative data with instructional chairpersons and attend Board of Education meetings.

## **Additional Requirements**

Once hired, instructional technology specialists must continue to attend professional development workshops and collaborate with colleagues to acquire more professional growth experience on a larger scale. Equally important, candidates must be able to summarize and interpret current learning theory and research development on second language acquisition as the Alianza Bilingue is a dual language district. "English language learners (ELLs) come into our classrooms with a wide variety of specific and unique needs for language acquisition. However, though there are so many apps and ed tech tools available, there are not enough that cater to English language development" (Knutson, 2020). ITS must be aware of instructional strategies, program services and literature from professional journals that compliment the vision and mission of the district.
