

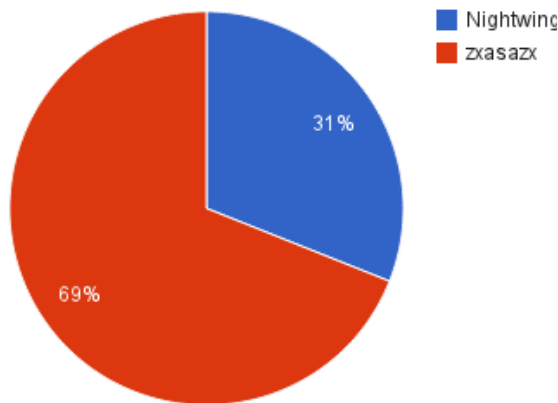

Analysis of Election Results

On the night of October 26, 2013. Chief Justice Nightwinga made a private concession to the Runoff election of the Executive Council. “The stability of the government is more important than its perceived inefficiency, at least for right now”. At the time of his private concession he had around 33% of the vote.
