#### 1. Introduction

The writing format is 2 columns with equal width, 1 cm column distance using A4 paper size (21x29.7cm). Text margins from left and top are 3 cm, right and bottom are 2 cm. Manuscripts are written in Microsoft Word, single spaced, Times New Roman 10pt and a maximum of 12 pages. Paragraph settings with a distance of 10pt on the after spacing and do not use the First Line Indent.

The title of manuscript should describe the content and use the fewest possible words. Avoid using words that make too long such as "A Study of...", "Investigation of......", "Implementation......", "Observation on.....", "Effect.....", "Analysis...", "Design...", etc. Article search depends on the accuracy of the title, the keywords also help in searching references.

The maximum number of words in the title is 14 words which refers to the Higher Education Accreditation rules.

The introduction should describe clear background, statement of the problem, literature relevant to the subject, the proposed approach or solution, and novelty of the research containing the innovation. (Birtha, Arifudzaki; Soemantri, Maman; Abdian, 2010)

Management and citation of bibliography made in APA style. Terms in foreign languages are written in italics. The articles are presented in a section structure: Introduction – Research Methods/ Algorithms (optional) - Results and Discussion -Conclusions. (Liza & Yupinti, 2012)

The literature review can be used by the author in the "Introduction" chapter to explain the difference between research and other articles, that writing is the latest innovation. (Han & Kamber, 2006)

If the research has high originality, which proposes a new method or algorithm, additional chapters after the "Introduction" and before the "Research Method" can be added to briefly explain the proposed method or algorithm. 
