The increase in rice prices from IDR 7,000 to IDR 9,000 per kilogram has resulted in a rise in farmers' revenue from IDR 31,703,000 to IDR 40,761,000, reflecting a 28.57% increase. However, this growth in income does not lead to a significant improvement in farmers' welfare. During the same period, farmers' expenditures rose by 31.45%, surpassing the rate of income growth. This condition indicates that although farmers earn more from selling rice at higher

prices, the additional income is quickly absorbed by increasing production costs and rising household expenses.
