# **Application Standards**

All applicants pass through a screening process:

**Credit History**To determine satisfactory creditworthiness we run a report through a credit-reporting agency.

**Rental History** Your previous residencies must be free of evictions, judgments, and unpaid rents.

**Occupancy** The number of occupants may not exceed 2 persons per bedroom.

Pets/Smoking No pets are allowed on the premises (unless needed for medical/disability reasons, etc.) and the pet policy is strictly

enforced. Smoking/Vaping is not permitted inside the premises by anyone.

Utilities Utilities (Water and Electric), utility fees/deposits are to be paid by the tenant. HOA dues are paid by the owner.

# Submitting Your Application - Summary

- 1. **Complete the Application Form** The form must be completely filled out and signed before it can be processed. Missing information will result in processing delays.
- 2. **Submit Copies of Recent Pay Stub** Provide a copy of your most recent pay-stub to submit with your application. If you are combining income to qualify please provide a pay-stub for each applicant.
- 3. Payments:
  - \$\frac{90}{0}\text{applicant application fee} \text{This consists of a non-refundable application processing fee}. Every adult occupying the premises must fill out an application form and submit the application-processing fee. Please fill out the application on Zillow.com that will create a credit report and background check. Then look up the property on Zillow and apply.
  - \$(Same as Monthly Rent) earnest holding deposit This is a deposit to hold the property while the application is being processed. Once your application is approved, this will be applied towards the security deposit defined in the Rental Agreement (you will not lose it). If your application is not approved by the owner, it will be refunded. It is not refunded if the applicant backs out.
