

Privacy Policy

Last updated in July, 2020.

Tripti Kumari Apps, its subsidiaries and affiliated companies provide this Privacy Policy to inform you of our policies and procedures regarding the collection, use and disclosure of information we receive from users of (i) the website located at Tripti Kumari (the “Site”), including any services, features and content accessible or downloadable from the Site, and (ii) any other Tripti Kumari applications, service or product licensed, downloaded or otherwise accessed by such users through third party websites or sources ((i) and (ii) collectively, the “Service”).

WHAT INFORMATION DO WE COLLECT

We collect from you the following data:

a. Information you provide us directly. When you use our apps, we collect the information that you provide us directly:

Photos. We may collect the photos that you take with your camera while using our application. Please note, you won't be able to upload content from your camera roll unless we can access your device's camera.

Facial features. We use a third-party algorithm offered by Amazon Rekognition. The method detects the faces in the image provided by Users and extracts facial features into a feature vector. Later, extracted feature vectors are used to perform face match.

The camera images and resulting data (feature vectors) are only used for the purposes of comparison. Once a session is complete we do not retain any of this facial data. Facial data is never stored to a disk. We do not perform facial recognition on your facial data.

The app does not sync face data to a server or cloud. It is only transferred to and processed by Amazon Rekognition to obtain feature vectors from the provided face data.

b. Usage data. When you use our Services, we may collect information about your activity within our Services, for example, which pages you have viewed and for how long. We also may collect IP-addresses, the source of the traffic, information regarding the device and operating system, information about your wireless and mobile network connections, unique device identifiers, browser type, language, battery level, and time zone.

We collect usage data with the help of Google Analytics. With the use of Google Analytics, we collect such data as IP-Address, your device model, screen resolution and operation system, session durations, your location. Based on these data, we analyze your needs and interests, evaluate effectiveness of our campaigns and improve our Website to make its content relevant to you and the Website itself available for smooth viewing with your device.

c. Cookies and similar technologies. Like most online services and mobile applications, we may use cookies — tiny pieces of code that remain in your device after you have visited any websites and online services. When you use that website or application for the next time, these pieces enable their owners to provide you with information customized for your needs.

We use cookies for authentication purposes only. When you access the Services or content, iface uses session cookies, meaning that if you close the Services, cookies expire and no longer have any effect. You shall specifically agree to our use of cookies when you use our Services by clicking the respective button in the notification.

When you use the Services, we may also use technologies like pixels, web beacons, and local storage to collect information about how you use iface and provide features to you.

HOW WE USE YOUR INFORMATION

We use information that we collect about you or that you provide to us, including any personal information, to:

- Provide you with the App and its contents, and any other information, products or services that you request from us.
- Fulfil any other purpose for which you provide it.
- Notify you when App updates are available, and of changes to any products or services we offer or provide through it.

The usage information we collect helps us to improve our App and to deliver a better and more personalized experience by enabling us to:

- Estimate our audience size and usage patterns.
- Store information about your preferences, allowing us to customize our App according to your individual interests.
- Recognize you when you use the App.

DISCLOSURE OF YOUR INFORMATION

We may disclose aggregated information about our users, and information that does not identify any individual or device, without restriction.

In addition, we may disclose personal information that we collect or you provide:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them.
- To a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Company's assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Company about our App users is among the assets transferred.
- To fulfil the purpose for which you provide it.
- With your consent.
- For any other purpose disclosed by us when you provide the information.
- To comply with any court order, law, or legal process, including to respond to any government or regulatory request.
- To enforce our rights arising from any contracts entered into between you and us.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Company, our customers or others

HOW WE STORE INFORMATION

Data retention. We generally retain your personal information for as long as is necessary for the performance of the contract between you and us and to comply with our legal obligations. If you no longer want us to use your information that we physically access and store, you can request that we erase your personal information and close your account. However, some data may still be stored for a certain time period if information is necessary

to comply with legal obligation (taxation, accounting, audit) or in order to maintain safety and data backup settings, prevent fraud or other malicious acts.

Data security. Tripti Kumari Apps takes reasonable measures to protect your information from unauthorized access or against loss, misuse or alteration by third parties. Although we make good faith efforts to store the information collected on the Service in a secure operating environment that is not available to the public, we cannot guarantee the absolute security of that information during its transmission or its storage on our systems. Further, while we attempt to ensure the integrity and security of our network and systems, we cannot guarantee that our security measures will prevent third-party “hackers” from illegally obtaining access to this information. We do not warrant or represent that your Account or any of Your Information will be protected against, loss, misuse, or alteration by third parties.

PUSH NOTIFICATIONS

With your consent we may send push notifications to your mobile device to provide app updates and other relevant messages.

SOCIAL NETWORK CONNECT

If you use one of our applications and connect to your social network account, such as Facebook, Twitter, Vine, Instagram, YouTube and so on, within such application, you will be providing us with basic account information i.e., user ID, name, email, gender, birthday, current city, profile picture URL and the user IDs of your friends who have also connected with our applications. In addition, we will cache data we receive from the Social Network APIs to improve our user experience. INVITE A FRIEND

We will not share your personal information in ways other than as described in this Privacy Policy unless you specifically elect to make your personal information available to third parties by selecting to “opt-in” in various places on the Service. Your “opt-in” elections will not, however, require us to share your personal information with any third parties. OUR POLICY REGARDING CHILDREN
