

Early Childhood Education: Initial Licensure

In order to be recommended for your Minnesota birth-grade 3 early childhood education teaching license, you must successfully complete the following licensure requirements.

Required Coursework

You must complete the following licensure coursework* with an overall cumulative GPA of 2.8 or higher and with individual course grades of a C- or better.

Clinical and Field Experiences

Field experience for UMN Twin Cities teacher candidates is an intentionally planned part of each licensure program. In order to be recommended for licensure, candidates in the early childhood education program must complete 782 hours of course-based field work prior to student teaching. This program culminates with 16 weeks of full-time student teaching.

Minnesota State Assessments

edTPA (Education Teacher Performance Assessment)

You must successfully complete and submit your edTPA portfolio, as stipulated by PELSB, before being recommended for your MN teaching license. edTPA is introduced in your program method courses, and you will complete it in conjunction with your student teaching. Follow the instructional documents available at our <u>edTPA resource website</u>.

Submitting Your Minnesota License Application

Once the above requirements are confirmed complete (via APAS, edTPA submission), you must submit your complete Minnesota teaching application to the Office of Teacher Education (OTE). You must follow the <u>teacher licensure</u> <u>application process</u> instructions. The OTE licensing team reviews your license application, and once verified that all of the requirements are complete, we email signed application documents to you. You then send your application packet to the Professional Educator Licensing and Standards Board (PELSB). This usually takes about 3-5 business days, two weeks, but can take longer during the busy summer season. PELSB typically takes 6-8 weeks to process a license; <u>you can look up your license progress online through PELSB's website</u>.
