Ahead of UNFCCC COP 25's anticipated approval of Article 6 the Indigenous Environmental Network and the Climate Justice Alliance are launching the Carbon Pricing Toolkit Vol. 2.

This toolkit has been nearly a year in the making. Author Tamra Gilbertson worked with Indigenous leaders across Mother Earth to develop this toolkit to deepen the understanding of the flaws in Article 6 of the Paris Agreement

Carbon Pricing Vol. 2 is a toolkit to help mobilize our communities to fight against the carbon pricing rhetoric in Article 6 of the Paris Agreement.

Article 6 of the Paris Agreement is being spun as giving countries the opportunity to cooperate with one another by using carbon pricing, cap and trade and offset schemes that create carbon dumping grounds. With climate collapse already happening before our eyes Indigenous and vulnerable communities we cannot continue to sell false solutions to climate change. A just transition centering Indigenous communities must be the center of all talks of climate action. Article 6 allows for extractive industries to keep the status quo and fails at addressing the rapid decline in our ecosystems across Mother Earth.
