Grades: This class will have a mid-term exam, a final exam, and 4 one-page papers. The mid-term will count for 25 percent of one's grade, the final for 35 percent, and the 5 short papers 35 percent. Class attendance and participation will count for 5 percent.

This is an introduction to Social and Political Philosophy. We will be considering abstract questions about what, if anything, gives the government the right to rule, the appropriate limits of government intervention into our lives, what justification can be given for democracy, and similar issues. We will also consider less abstract issues, focusing especially on issues of mass incarceration, race, and inequality.

Late Work Policy: For each day an assignment is late the final grade on the assignment is deducted 1/3 of a letter grade (including weekend days). So, e.g., if an assignment that is due on Friday would've received a B, but is instead turned in 3 days late on Monday, it now receives a C.
