## OVERALL RULES

- By purchasing characters or art from me, you agree that you have both read these rules and agree to my Terms of Service.
- I reserve the right to decline a sale, offer, or commission at any point before the transaction is finished for any reason. Refunds will be on a case-by-case basis.
- All preparation materials, visual and sketches, including but not limited to thumbnails and the electronic files used to create the project remain the property of the artist, Parziivale, unless otherwise specified.

- Paypal, Venmo, Cashapp, Zelle, Ko-Fi, Artistree, VGen, or Deviantart Points at at 100 pt = \$1 USD ratio
  - I do not take Cryptocurrency, and no art I sell is allowed to be used for NFTs.
- Please only send payment when requested, and send it within 48 hours unless otherwise specified. If not, the design will go back up for sale, or the art will not be completed.
  - This does not apply if you are paying on a payment plan- payment plans are a case-by-case basis. Talk to me about it, I'm often willing to work something out!
- If you break my Terms of Service, I have the right to refuse future service and add you to a block list.

## COMMISSIONS

### GENERAL WILL-DO'S

- Original Characters, Fan Characters, Canon Characters
  - Includes OCXCanon Ship Art, Self-Inserts, Personas, and IRL people
- Humans/Humanoids
- Characters of all genders, races, body types, and sexualities.
- Gijinkas and Kemomimis
- Armor (Within Reason)
- Furrries/Anthros
- Blood, Gore, Candy Gore

### GENERAL WON'T-DO'S

- Anything related to Racism, Sexism, Hatespeech, or Pedophilia.
  - This includes inappropriate and/or suggestive Loli/Shota. If you have to question it, I probably won't.
- Mecha
- Sexual NSFW
- IRL person fandom / RPF ships
- Animals/Ferals

### UPCHARGES FOR

- Complex Designs
- Armor
- Extra Weapons/Props
- Non-explicit Fetishes/kinks
- Tasteful NSFW/Nudity
- Excess Changes

## COMMISSION SPECIFIC RULES

- I will not begin until I am paid.
- For large commissions, (A flatcolored fullbody or more) sketch will always be sent for approval, and you are allowed 2 phases of changes to pose, expression, etc. Changes after the 3rd sketch is sent may be upcharged unless the error is my mistake.
- You may post and use your commission non-commercially anywhere so long as proper credit is given.
  - If looking to commission art for commercial use, please let me know upfront, or inform me later of your intent. I'm fine with drawing commercial use art, as well as doing a later purchase for commercial usage, but I would like to be informed and properly credited
  - If reselling a character I have drawn for a commission, you may add up to the price you paid for the commission to the value of the character during appraisal. You may not add more value to my art than what you paid, regardless of if you got the commission on sale or if my prices increased. You do not have to add the full value if you do not want to, however.
- You must have a visual reference of some sort. Dollmakers/dress up games and screenshots are okay. Written references will not be allowed.
- If I am unable to complete your commission for any reason, I will refund the points/money.
  - I do not give full refunds after the sketch phase unless an error has been made on my end. "I don't like it" will not be given a full refund.
- If you repost on Toyhou.se, please credit on-site user Parziivale.
- Please be patient, I will get to your art as soon as possible.
  - You may note me after two weeks asking for an update if i have not sent you one already. I will try to stay in contact as frequently as possible about it.

## ADOPTABLES

### GENERAL ADOPTS

For designs created by [Parziivale](#)

- Give credit to me on the design's reference sheet wherever you post it. You don't need to do it on every piece of content connected to the design, but on the reference sheet I insist on it, everywhere else it's appreciated.
- You may modify my designs as much as you wish, simply credit me for the original design and original art.
- You may commission other artists of any trade to create content for the design.

- You can use designs I've made for commercial use, I don't care. Just credit me, Parziivale, in product descriptions or credits.
- You may trade or gift characters as you wish, but please do not sell for more than you bought them for unless they have extra art.
  - Price the art fairly, if it's your art, and price the character fairly as well! Do not buy them, add one piece of small art, then bump the price up double. C'mon, man, just be reasonable and not a scalper.
  - If you receive a character from me in a trade, please do not use them as trade fodder within 2 months of receiving them, especially without adding any other art to them. If you no longer want them after only a few weeks to a month, whether due to "not connecting" or otherwise, please contact me and we can talk something out. I will reimburse your trade for something of equal value.
    - This rule does not apply for monetary transactions or if you've added extra art to the character.
- You may create, commission and otherwise request nsfw content of my designs so long as they are of adult characters. Characters younger than the equivalent of 18 in human age need to be aged up and this must be visible in art of them for nsfw content. No shotacon/lolicon or pedophilia, if that wasn't clear enough.
- You may age the characters up or down, but again: avoid pedophilic implications.
- Do not use a character I've designed to advocate for, encourage or commit any illegal activity, discrimination or hatespeech. The latter two are in this context defined as "prejudice plus institutional power", not merely as "hate" or "anger". It's fine if you disagree with this definition, but understand that it's the one applicable to this specific terms of service. Of course you can make an asshole thief character who holds opinions different from your own and encourages other in-story characters to steal, but make sure to distinguish between your and their opinions and to keep art or writing about them from turning into a mouthpiece for oppression.
- If you upload to toyhouse, please credit my on-site account there, Parziivale!
- If there is extra art attached to the characters, please credit the original artists of that art, don't erase credit!

## THIRD PARTY DESIGNERS

These are rules for resold characters not designed by me!

- Follow the Third Party Terms of Service. I will try to provide it as often as I have it, so please keep that in mind.
  - I often keep this logged in the character's Toyhouse Ownership Profile, so double check that!
- Please do not remove credit for art I have done of the character

- Please credit me as having been a previous owner so that character ownership transfer is clear.

Breaking these rules and/or going against my ToS means you may be blocklisted and denied future services.

These rules might be subject to change, and I recommend checking back every now and then to make sure you're still well informed. Thank you very much!
