This newsletter serves as a monthly update on what's new with the Archival Digitization teams at the History Center. Each month, we will send out a brief update on recently completed digitization projects and team accomplishments, as well as general information about who we are and what our work is actually like.

Who are we?

We are the staff who provide digitization services at MNHS, which involves converting analog materials into digital copies to allow broader accessibility of materials held in our collections. Working with both internal and external requests, we digitize to create digital copies of materials, ranging from manuscripts and photographs to video and audio cassettes, that would otherwise only be accessible in person. While many of our digitized projects are made available online, some digitized content can not be published. Newspapers and serial digitization is handled by a separate team, led by Anne Levin.
