Buyer agrees to place a \$_____ non-refundable deposit on ___ Miniature Schnauzer puppie(s) from
Lowcountry Dreams Heritage Farm.

The final amount due is \$_____ and any costs associated with travel/shipping of puppies.

The total price of the puppies is \$_____ to be paid in full before the puppies leave the breeders possession. This is a Non-Refundable Deposit, but can be put toward the full purchase price or another puppy if, for some reason, this puppy becomes unavailable or the buyer decides this puppy doesn't fit for them before the final sale of the puppy. However, if all other puppies are reserved, then the buyer agrees to be put back on the waitinglist until another puppy becomes available. Buyer acknowledges that the Deposit is non-refundable in all circumstances, including but not limited to if Buyer decides they do not want or is no longer able to take the puppy. Upon receipt of the deposit, Breeder agrees to hold the puppies for the Buyer until they have been weaned and are ready for pick up. If the buyer pays the Deposit, then later decides they do not want the puppies for any reason, the breeder is not required to refund the Deposit.

Buyer Acknowledgements.

Buyer further acknowledges and agrees that Breeder cannot and does not guarantee any specific qualities of the puppies when they become adults. Final Purchaser Price. Breeder and Buyer agree that (a) the Deposit shall be applied to the final purchase price of the puppy(s) and (b) the remaining balance will become due before the puppy(s) are transferred and/or ownership is transferred from Breeder to Buyer.

The total purchase price for the puppy(s) is \$ _____. The foregoing purchase price does not include any delivery or shipping charges.

Breeder Guarantees. The Breeder guarantees the puppies to be healthy and free from any illness at the time of the purchase. The puppies will have their first set of vaccinations. The Breeder strongly encourages the Buyer to have the puppies seen by a veterinarian of the Buyer's choice within 72 hours of taking ownership of the puppies.

Returns. The Buyer may return the puppies for any reason within 72 hours after the purchase, provided the puppies have not been damaged in any way. The Buyer is responsible for all costs associated with travel to return the puppies to the Breeder. The Buyer will be entitled to a refund of the paid price, less the non-refundable deposit. After 72 hours, the Breeder is not required to refund the paid price, but may do so at their discretion.
