The author should indicate what they aim to achieve (problem-solving) and, if possible, highlight the scientific significance or novelty of the study.<sup>2</sup>

At the end of the paragraph, the author should conclude by emphasizing the importance of identifying the problem<sup>3</sup> and the research objectives.<sup>4</sup>

## RESEARCH METHODS

Every article derived from research must include a research methodology. The research methodology is a series of technical steps taken by the researcher in their study. It is not about discussing the definition of a method.<sup>5</sup> The research methodology should include the approach used, the type of research, and the data sources (described descriptively and must provide a statement regarding the research methodology). This method should give the reader a clear picture.<sup>6</sup> The methodology used must be accompanied by references and formulated concisely and clearly.

## ANALYSIS AND DISCUSSION

This section is the most important part of your article. The analysis or research results must be clear and concise.<sup>7</sup> The findings should summarize the scientific discoveries and provide detailed data. It is expected to highlight the differences between your results or findings and previous publications by other researchers.<sup>8</sup> For tables and figures, you need to follow the model below:

For the verse, use the default font of the al-Qur'an in Word application (**LPMQ Isep Misbah**) with a font size of 12 pt, and for the translation, use a font size of 11 pt.

All publications cited in the text must be included in the bibliography, arranged alphabetically by author. For example:
