## **Welcome and Introductions**

### Parent Book Study - Dani & Corinne

- How to Be An Antiracist by Ibram X. Kendi
- Chapters 1-9 will be reviewed in Apri 8th 6pm virtual meeting, remaining chapters at May 6th at 6pm virtual meeting
- Book study with staff went really well
- Amy Nelson said she would be happy to attend beginning of virtual meeting
- Sign up by March 18th Sign Up Spreadsheet so we will know how many facilitators needed

#### **Teacher Update**

- Book study staff has had really good conversations about unconscious biases and applying to the classroom and also looking at what needs to change
- Staff is more conscientious of curriculum
- FPC curriculum is culturally diverse and has high quality literature

### **Principal Update**

- UIP Goals similar format as last year
  - One goal, one focus reducing significant reading deficiencies (SRDs) identified through reading plans. SRDs are when a student is one and a half years below reading level or identified as having reading learning challenges. SRDs are only initiated in K-3. SRDs will be updated and revised in grades 4-5.
  - Currently, 7% of Fireside students have SRD. This includes AIM program. Fireside looking at ways to reduce.
  - Fundations and FPC curriculum are assisting
  - As there will be more minutes in Fireside's school day next year determining how to use and what that does to schedules

- Instructional Infrastructure common scope and sequence for teaching primary content areas and blanket assessment system. Will be three District formative assessments throughout the course of the year. Culturally and Linguistically responsive pedagogy, collaborative structure, MTSS and Common Instructional Model (series of steps/learning framework)
- Dyslexia Screener given to Kindergarteners in the Fall, some done remotely. They will go back and review the data in the Spring. This is a pilot year.
- Parent commented that Lexia has been really helpful
- CMAS Plan April 21, 22 & 23 and again April 27, 28, & 29. Note the testing is only about 2 hours per day and the majority of students are finished before the end of that time allotment. Math and reading for 3-5, 5th also has science. Plan will be to disburse additional information to the community once a plan is in place. We aren't yet sure how the state will be reviewing the data but there are potential repercussions if too many opt outs.
- 2021-22 Enrollment currently 425, 475 last year. Steadily increasing. Next year's enrollment at 402 but anticipate it will rise. Typical to be a little lower at this time of year as kinder still registering. Third grade numbers for 21-22 are low. 56 total at present. Rest of grades fairly steady.
- 2021-22 Staffing Changes. Staffing plans generally come right around spring break. None anticipated at present.
- Staff Vaccination status roughly 95% of Fireside staff have been vaccinated. BVSD states that we cannot require every employee to be vaccinated.
- Student catch-up plans opportunities for catch-up, some teachers or paras are seeing kids on Mondays or after school. Summer school numbers will probably be elevated compared to prior years. Geared towards academic gaps. Summer school lists were generated from the District and parent's noted communication was a bit lacking.
