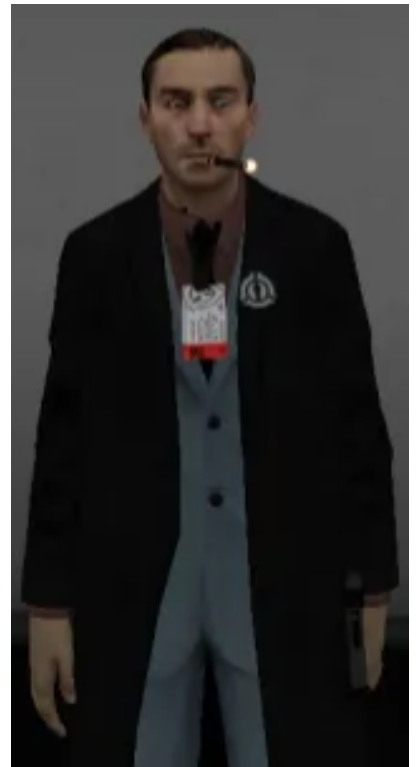

Harlow's Background Info

Harlow was born in a city called [REDACTED] in the Czech Republic. After completing medical school, he achieved significant success as a doctor, eventually rising to the position of Senior Consultant. Due to that fact, Harlow was promoted to the new DoM by the Site Director. However, after serving as the DoM for 68 days, Harlow began to feel overwhelmed and requested a reassignment to Internal Affairs. The Site Manager and Director of Internal Affairs accepted his request, and he was given the role of an Internal Affairs Operative.

After 15 days in Internal Affairs, Harlow requested another reassignment to become an Ambassador. This request was approved, and he served as an Ambassador for two months. He then requested a reassignment to Ethics Committee Assistant, which was also approved, resulting in Harlow taking on the role of Assistant.

In this position, Harlow did really well. He carried out the Committee's orders and even assisted with Site Advisor tasks when he had spare time. Harlow conducted multiple interviews, participated in various investigations, and even tried to start an [operation](#), though it was shortly after terminated.

After that, an SA spot opened due to an assassination by insurgency. Following the assassination of a Site Advisor by a CI Deep Cover member, Harlow grasped the opportunity and applied for the vacant Advisor position. His application was accepted.

As SA, he did decently. He was in his position for a month until he got kidnapped by ci. It is currently unknown how he got kidnapped in the first place. After recovery, Class-F amnestics were discovered in his blood.

Unfortunately the effects of Class-F were not reversible, which resulted in his demotion to Senior agent to relearn.

After that, he was recovering his skills, resulting in his promotion to special agent and shortly after promotion to Manager.
