Privacy Policy

Barbie Kalev, Inc. ("BKI", "we", "our", or "us") respects your privacy. This privacy policy ("Privacy Policy") applies to our information we collect when you visit BKI websites, including the website located at www.barbiekalev.com (the "Site"), or other online or mobile service that displays or links to this Privacy Policy (collectively, the "Services"), register to receive communications from us, or otherwise interact with us as described below. Capitalized terms not defined in this Privacy Policy shall have the meaning set forth in our Terms of Use.

1. YOUR ACCEPTANCE OF THIS PRIVACY POLICY

By accessing, using, or purchasing any Products through the Site or any Services, you signify your acceptance of our Privacy Policy. If you do not agree to this Privacy Policy, please do not use our Site or any Services. We reserve the right, at our discretion, to change, modify, add, or remove portions from this Privacy Policy at any time. This Privacy Policy is subject to change without prior notice. For that reason, we encourage you to review this Privacy Policy periodically and to make note of the date of the most recent revision. Your continued use of our Site or any Services following the posting of changes to these terms means you accept these changes.

2. INFORMATION WE COLLECT

We may collect both personally identifiable information ("personal information") and non-personally identifiable information through the Site and certain Services. Personal information may be collected when you register or submit information through our Site or any Services. We collect non-personally identifiable information through the use of general tracking information and click path tracking (cookie technology) described below. We may also collect information from third parties, including marketing service providers. We may combine the information collected from these sources with other information in our possession.

3. USE OF PERSONAL INFORMATION

When you sign up to receive any of our newsletters or other resources, respond to a survey, or register for or purchase any Products through our Site or certain Services, you may be required to provide personal information such as your name, email address, street address, city, state, zip code, phone, social media information, and/or other such information. If you correspond with us or submit comments or suggestions, your personal information may be included in our internal database system. We may also use this information to process and fulfill orders, respond to your emails, questions, comments and suggestions, notify you if you have been selected as a winner of a contest or sweepstakes, provide customer support, send you emails about our Site, Services, or Products, new products or services, special

4. USE OF NON-PERSONALLY IDENTIFIABLE INFORMATION

When you browse pages on our Site, we also automatically receive your computer's Internet Protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system. Your IP address is a number that is used by computers connected to the Internet to identify your computer so that data (such as the web pages you request) can be sent to you. We may aggregate this data with data on the pages visited by other users to track overall visitor traffic patterns. We use this information to improve our Site by making it more responsive to the needs and preferences of our users. This information does not identify you personally.

A "cookie" is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. This website uses cookies to help identify and track visitors, their usage of the website, and their website access preferences. Visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using websites that collect them, with the drawback that certain website features may not function properly without the aid of cookies.

We may also use web beacons in order to recognize users and assess traffic patterns, and we may include web beacons and cookies in our email messages in order to count how many e-mail messages have been opened. 5. DISCLOSURE; INFORMATION RETENTION AND DELETION

Disclosures to Public Authorities

In certain situations, we may be required to disclose personal data in response to lawful requests by public authorities, including to meet national security or law enforcement requirements. We may also disclose personal information to other third parties when compelled to do so by government authorities or required by law or regulation including, but not limited to, in response to court orders and subpoenas.

6. THIRD-PARTY SERVICES

Like many businesses, we contract with other companies to perform certain business-related services. We may disclose your information, including personal information in some cases, to certain types of third-party companies, but only to the extent needed to enable them to provide such services, including, without limitation, technical assistance, order fulfillment, customer service, marketing assistance, payment processing, survey collection, promotional and marketing assistance, and business operations. Information Collected Through the Facebook Community Group

This Privacy Policy does not apply to any information (including personal information) that you provide using the Facebook Community Group. Use of the Facebook Community Group is governed by Facebook's privacy policy. All such information is public information and may be seen, collected or used by any user of our Facebook Community Group.

8. PROTECTION OF YOUR INFORMATION

We utilize third-party payment gateways and payment processors, such as PayPal or Stripe, for all purchases, and your credit card or other payment information will be stored on these payment gateways according to their respective privacy policies. We do not store any of your credit card or other payment method information. We use commercially reasonable procedures to protect the personal information that we collect from you against loss, theft and misuse, as well as unauthorized access, disclosure, alteration and destruction. These procedures are appropriate to the size, scope and type of our business, the resources available to us, the amount of stored data and the need for security and confidentiality of the personal information we store. No security system is impenetrable. We cannot guarantee the security of our databases or the security during transmission to us of the information you supply over the Internet. You can help us by taking precautions to protect your personal information when you are on the Internet and only disclose information that you want made public. Change your passwords often using a combination of letters and numbers and make sure to use a secure web browser.
