In the case of sending the form in a paper version, it should be completed legibly and signed with a handwritten signature.

In the case of sending the form in an electronic version, it should be completed on a computer or, as for the paper version, and scanned in a legible form.

INFORMATION ABOUT THE RIGHT TO WITHDRAW FROM THE AGREEMENT

Within 14 days from the conclusion of the contract, you have the option to terminate it without giving any reason.

The Mint of Gdańsk emphasizes that this provision does not apply to the purchase of gold and silver bullion coins and bars, because pursuant to Art. 38 of the Act of 30 May 2014 (Journal of Laws of 2019, item 134) on consumer rights, the right to withdraw from a distance sales contract is not available to the consumer, in which the price or remuneration depends on fluctuations in the financial market over which the entrepreneur does not exercise control and which may occur before the deadline for submitting a declaration of withdrawal from the contract.

The withdrawal period will expire after 14 days from the day on which you acquire, or a third party other than the carrier and indicated by you acquires, physical possession of the goods.

To exercise the right to withdraw from the contract, you must send an unambiguous declaration of withdrawal to the address of Mennica Gdańska (ul. Matejki 20/1, 80-232 Gdańsk or logistyka@mennica-gdanska.pl).

In order to submit a declaration of withdrawal from the contract, you have the option of using the above template. It is also possible to send the declaration in a different form. The declaration must include the name, surname, address and order number).

To keep the deadline for withdrawing from the contract, it is enough for you to send information regarding the exercise of your right to withdraw from the contract before the deadline to withdraw from the contract.

In the event of withdrawal from this contract, the Gdańsk Mint will refund all payments received from you, including the costs of delivering the goods (except for additional costs resulting from the method of delivery chosen by you other than the cheapest standard delivery method offered by us), immediately, and in any case not later than 14 days from the date on which the Gdańsk Mint received your declaration of withdrawal from the contract.

The payment will be refunded using the same payment methods that you used in the original transaction, unless you explicitly agree otherwise.

The Mint of Gdańsk has the right to withhold the reimbursement of the payment until receipt of the goods or until proof of sending back the goods is provided.

The goods are returned at the consumer's expense.
