		Public Hearing - Staff provided a presentation of the project application. Linda Gustainis provided an additional overview of what she expressed as fairly straightforward repairs with everything being "in-kind", and an explanation of her trying to get on a regular maintenance schedule for the entire HOA, and difficulties of trying to get the project going. June 3rd the lift is expected to be delivered, followed by roofing repairs, followed by painting, they aren't sure of the timeline for the masonry work. Tom asked when the last time work on the roofs were done. A discussion ensued regarding the difficulty in matching slate colors and when the last repairs were completed to the buildings. Linda's understanding was the Redstone had rehabilitated the buildings before they were sold as condominiums, but isn't she if they completed work to the outside. Linda was asked to provide an overview of the 20% Historic Tax credit application. After Linda's overview members of the public were invited to speak.
