Text tips

1. Article/blog post has to have:
 - The main title (header H1)
 - No less than 3 sub-headers
 - Numbered or bulleted lists
2. Article body should be broken into short blocks with defined margins (NOT the empty paragraphs).
3. Text has to be free of plagiarism (not less than 80% of uniqueness)
4. Internal links must be **relevant**, thus, useful to a reader.

5. Table of Contents should be displayed at the very beginning of an article/blog post. It has to include all article/blog post headers and links allowing the user to immediately jump to the part of the copy they are most interested in
6. Add images, diagrams, schemes, tables, infographics, comparison tables, etc, where necessary.
7. **Highlight** the keywords, both main and additional ones, you used in your text. It will significantly simplify the reviewing process for the SEO specialist.
8. Avoid placing more than three long sentences (10 words or more each) in a row. Similarly, avoid three short sentences in a row.
