- I. CALL TO ORDER- The meeting was called to order by Supervisor, Jason Killoran at 6:00 p.m.
- II. PLEDGE OF ALLEGIANCE- The Pledge of Allegiance was recited.
- III. ROLL CALL  
Spurr Township Board Members: Supervisor, Jason Killoran, Treasurer, Tammy Marier, and Trustee, Dennis Bentti, Trustee, Joel LePage, Deputy Clerk, Vickie Voegtlle. Absent: Clerk, Jessica Omernick. Quorum is present.
- IV. AGENDA APPROVAL- Add under IX. New Business "f. new member to Board of Review. Motion made by Trustee, LePage to approve amended agenda seconded by Trustee, Bentti. 4 Ayes. 0 Nays. Motion carried.
- V. APPROVAL OF MINUTES- December 18, 2023, Regular Board Meeting- Motion made by Trustee, Bentti to approve the minutes, seconded by Treasurer, Marier. 4 Ayes. 0 Nays. Motion carried.
- VI. ACCOUNTS PAYABLE
  - a. Remove check payable to Joel LePage for \$114.78 due to him not being present at December's board meeting. Motion made by Trustee Bentti to approve amended Accounts Payable of \$21,077.21 minus \$114.78 to total \$20,962.43 and seconded by Treasurer, Marier. 4 Ayes. 0 Nays. Motion carried.
- VII. OFFICER REPORTS
  - a. Supervisor- Review Budget
    - i. The following budget resolutions will move money from the general fund.
      1. Motion by Trustee, Bentti, Seconded by Trustee, LePage to amend account 336-860 Mileage Fire Department from \$500 to \$600.
      2. Motion by Trustee, Bentti, Seconded by Trustee, LePage to amend account 336-900 Fire Department Advertising \$0 to \$100.
      3. Motion by Trustee, Bentti, Seconded by Trustee, LePage to amend account 336-930 Repair and Maintenance Fire Department from \$3,000 to \$3,500.
      4. Motion by Trustee, Bentti, Seconded by Trustee, LePage to amend account 336-955 Miscellaneous Fire Department from \$1,000 to \$1,400.

  - b. Clerk Report- Deputy Clerk, Voegtlle gave the Balance Sheet by Class to the board. In total the township has a positive balance of \$810,978.65 including all the millage accounts and general funds.
  - c. Treasurer- No treasurer reports this month.
  - d. Fire board- Supervisor Killoran read the fire board minutes from the 1/2/24 meeting. December bills included the Mining Journal, which should have been Michigamme's responsibility because Spurr had put an ad in the L'Anse Sentinel. There was also a bill from Pomasl for work gloves for \$963.53. There

were 2 fire calls during the month of December. Supervisor, Killoran to reach out to Eagle Mine for a donation towards the rescue boat. Chief, Perry submitted the proposed budget for the Fire Department.

- e. Planning commission- Trustee, Bentti gave an update from the meeting held on 1/11/24. There were three members present and no public present. The member present went over the master plan.
- f. Zoning Administrator- ZA, Mike Simula gave an update. All requests are just hearsay until a formal permit is filed with the Township. People are starting to call and plan for this upcoming building season.
- g. Assessor- Supervisor, Killoran gave an update. We will be down a member for the Board of Review.

- a. ORV Update- Supervisor, Killoran gave an update on behalf of the trail authority. Baraga Economic Development met with the ORV group. Want to meet with Tech in the next few weeks to discuss going through their property in Alberta. Still in the process of working with C&N for railroad access.
- b. Ohio Mine Culvert Update- Supervisor, Killoran has not had an update since December. The water levels are staying down.
