About the Assessments

Name	Purpose			
ACCESS for ELLs, Alternative ACCESS for ELLs, and WIDA Screener	Each of these assessments measure the language proficiency of students who are multilingual and receive support for developing their English proficiency. The assessments help identify ML students who benefit from support in their English development. Students' skills in Speaking, Listening, Reading, and Writing are assessed and used to identify language support			
Required by: State and Federal	needs. Additionally, scores on the ACCESS for ELLs or Alternative ACCESS for ELLs help educators determine when students no longer need support developing their academic and social English proficiency.			
Length of Assessment: Untimed. The assessment has four sections. Each section can take 30 to 65 minutes.				
CMAS (Colorado Measures of Academic Success) and CoALT (Colorado Alternative Assessment/Dynamic Learning Measures)	Both the state and federal government require annual testing in ELA and math. Additionally, Colorado mandates testing of science in grades 5. Some schools are selected by the state to complete social studies testing in grades 4.			
Required by: State and Federal	The purpose of the Colorado Measures of Academic Success (CMAS) is to measure the degree to which students have mastered the Colorado Academic Standards in English Language Arts, mathematics, science, and social studies, providing data for students, families, educators, and districts to assess academic progress and instructional effectiveness. The assessments			
Length of Assessment: generally 3 sessions for each content that last from 60 - 120 minutes long	help determine if students are on track for college and careers and inform adjustments to instructional programming.			
CoALT/DLM - an average of 7 testlets per content area. Each testlet is 5-15 minutes long.				
NNAT (Naglieri Nonverbal Ability Test (NNAT), Renzulli Learning Profile and NGAT (Naglieri General Ability Tests)	NNAT is an assessment that evaluates a child's ability to recognize patterns, understand relationships between shapes, and perform visual-spatial tasks. We use this assessment in 2nd and 6th grades as a universal screener to help identify gifted students. This assessment helps us ensure that a student with high cognitive potential can demonstrate that potential despite a language barrier or learning difference.			
Required by: State and District				
Length of Assessment: NNAT: 30 minutes	Renzulli Learning Profile helps identify student strengths, interests, and communication preferences. The student is then given personalized learning opportunities designed to support their cognitive needs.			
Renzulli Learning Profile: 20 - 45 minutes NGAT: 30 minutes	NGAT measures general ability through three components: verbal, nonverbal, and quantitative. Information about these skills helps us determine if a child is gifted and could benefit from instruction that challenges them.			
MAP Growth Required by: District	MAP Growth assessments are online tests in language arts, math, and science. These assessments are adaptive meaning each student will get a unique set of questions based on how they responded to previous questions. This helps pinpoint a student's achievement and areas of growth. The assessment is also a good predictor of achievement on CMAS.			

Length: Untimed though the average content-area test is 45-60 minutes.				
NAEP (National Assessment of Education Progress	NAEP is given to 4th and 8th graders and measures academic progress and is used to determine the academic progress across the country and over time. It is the largest nationally representative and continuing assessment of what our nation's students			
Required by: Federal	know and can do in various subjects. It also provides valuation insights into students' educational experiences and opportunities to learn in and outside of the classroom. NAEP is congressionally mandated by the National Center for Education Statistics			
Length of Test: 90-120 minutes	(NCES).			
Given every 2 years to a select group of schools. The assessment will be given in 2025/26.
